
1454 (12 November) in the reign of King Henry VI, indenture in Latin on vellum being a grant (300x135mm) by Ralph Couper and William Couper of Hawstead (just south of Bury St. Edmunds in Suffolk) to Thomas Coke of Great Welnetham, Roger Drury of Hawstead, Nicholas Helpston of Rushbrook, John Smyth of Stansfield, Robert Coket of Bury St. Edmunds and Geoffrey Gyppes of Hawstead. The grant is of a messuage and a piece of pasture of six acres and a piece of arable land in Hawstead; the messuage and pasture at "haustedgrene", abutting east on the common pasture called "halstedgrene" and the piece of arable land (one acre) in the field called Jelyonsfeld, with the land of the rector east, and the aforesaid pasture north. 



1565 (1 September) exchequer warrant from "Richard Mynstley" requesting "the allowance for riding by the commandment of the Right Honourable Lord High Treasurer of England from his place in London into Leicester, thence to Loughborough to my Lord Loughborough and to him delivered a writ with my Lord's letters, and so returned again to London to my Lord" with payment to be "IIs VIIId" (2/8d.). With "receipt at Westminster. I was on this journey xv days - paid full allowed". Photo



2011 1592 (2 November) indenture on vellum regarding two messuages in St. Stephen's Alley, requiring that Thomas and Margaret Arbewaye convey them and two others in Little Sanctuary to Edward Doubleday and James Wheatley. With two almost complete seals, one with an image of a bird, the other with an image of a flower. Photo

Four Indentures on vellum dating c.1550-1613. c.1550 indenture for transfer between a John Bollome and a John Lamby, with complete wax seal. 1564 (30 March) indenture relating to the Parish of St. Margaret's, Westminster, transferring two messuages in St. Stephen's Alley from Godfrey Harrystone of Putney and his wife, Joanna, to Gawaine Udal, of Westminster for £84, with good armorial seal. 1594 (8 November) indenture raised by the Gibbs family with two complete and one partial wax seal. Generally clean and well preserved. 1613 (12 July) indenture regarding the marriage of Margaret Maphson, daughter of Edward Maphson, with complete seal.

Richard Palfreyman

1607 (29 October) invoice on plain paper with cut edges. The invoice is from Richard Palfreyman, Keeper of the Armoury in the Tower and the Minories detailing money due by His Majesty to the Office of the Ordinance "for Provisions wages & for one yeare and one quarter endinge at Michelmas laste 1607. The som of Seaven thowsande five hundreth pownds"; signed "Ric: Paulfreyman" to the bottom right.

Sir Edward Conway



1618 (16 June) autograph letter of attorney written on paper folded in the usual manner with signs of ageing on the reverse from Sir Edward Conway. The letter details the appointment of William Stannarde, his attorney, to receive £125, being a quarterly payment due 24 June past out of an annual sum of £500 "payable out of his [the King's] exchequer". Signed and with wax seal intact, a little cracked.


Sir Edward Conway, 1st Viscount Conway, (1564-1631) during his esteemed career he commanded a foot regiment during the sack of Cadiz (1596), then went on to become the Governor of Brill (1624), Secretary of State (1623-30), and Governor of Isle of Wight (1625).











Marchamont Needham


2015

c.1621 bill written on paper folded in the usual manner from Marchamont Needham for various legal expenses. Signed by Sir Henry Hobart, Sir James Fullerton, Sir Oliver Cromwell, Sir Richard Smyth, Sir Thomas Trevor, and at the bottom by Needham as a receipt for the £10. Expenses includes; "a lease made to Sr. Adam Newton of certain lands which were for securitie of moneys &c." Another lease to "Sr. Richard Smtih for ye like purpose Five Breefs of ye Cause in Starchamber against ye palebreakers at Berkhamstead ..." A commission to "Sr. Robert Carey and others to survey ye wardrobe at Denmark House.". Photo

Marchamont Needham (-1621), father of the journalist of the same name who became renowned for his involvements with Oliver Cromwell, Lord Protector of the Commonwealth of England, Scotland, and Ireland from 1653 until his death after having signed King Charles I's death warrant. Cromwell's uncle of the same name gives his signature to this document.





Lionel Cranfield, 1st Earl of Middlesex

2016


1623 (August c.) petition written on paper and mounted on card, of Thomas Bayley to Lionel Cranfield, signed by Lionel Cranfield. In this petition, Bayley begs of Cranfield to aid in receiving "odd monie" of £5 owed to him by one 'Bagnall'. Bayley appears to be in great need of the money "it being a greate parte of his poore estate, having a wife and manie Children to mainteine" and has been met with difficulty in extracting the money from Bagnall who changed his lodging to "an unknowne place". Cranfield's sympathy appears to have been gained as he instructed Sir Robert Pye to "take some course with Mr. Bagnall, at his next receaving of money out of ye Eschegr, to pay this poore man ...". Lionel Cranfield, 1st Earl of Middlesex and Lord High Treasurer, merchant and politician (1575-c.1645). Notable also for the fact that his collections became part of the Sackville Papers, formerly at Knowle and now largely deposited in the Kent Archives Office. Sir Robert Pye, Remembrancer of the Exchequer (1585-1662). Both he and his brother Sir Walter Pye, Attorney of the Court of Wards, attacked the Treasurer in 1624. Robert Pye supported the Royalist cause during the English Civil War and garrisoned his mansion at Farringdon only for it to be besieged by his own son, Robert who supported the Parliamentary cause.







Philip Herbert, Earl of Pembroke

2017

1623 (30 November) order addressed to Thomas Fauconberg, to pay Sir Dudley Carleton £50. Signed "Pembroke&Mont", also signed "Northumberland" by Algernon Percy, Earl of Northumberland, "Salisbury", "Hen: Mildmay" by Sir Henry Mildmay and "Cor: Holland" by Cornelius Holland. With Signed receipt on the reverse by Dudley Carleton. Mounted on card. Included with 1701 (20 May) part printed Exchequer warrant with manuscript insertions for £40 from Lord Fitzharding. Signed "Will. Cooper". Photo

Philip Herbet, Earl of Pembroke (1584-1650) became Lord Lieutenant of Kent and member of the privy council in 1624. Pembroke had close ties with the crown established during James I's reign - James had paid off Pembroke's gambling debts and made him a Knight of the Garter and high steward of Oxford. Pembroke and his older brother, William were active literary patrons, and "the incomparable pair of brethren" to whom the First Folio of Shakespeare's works was dedicated. Mildmay and Holland were declared regicides on Charles I's death.



Anthony Crosier

2018

Undated. Petition of Captain Anthony Crosier written on paper folded three times vertically, to the Lord Treasurer stating that: "about 9 monthes since" the King was pleased to grant a pension of £40 per annum for life to Crosier and his wife, in consideration for "the carefull and dangerous undertakings of your petitioner in his Majesties services, which when all others refused, he undertooke, and performed, sinckinge a shipp againste the Cittadell, in the service att the Isle of Retze; (and there endureinge the shott above 3 weekes, and yett brought of the shipp." But they have not yet received the pensions, and "in passing the graunte, have had an addiction to further miserie, in pawninge & borrowinge to pay the fees". Signed "Cap. Crosier".

It is unclear where this document fits with this story, but is nevertheless a tantalising piece of history

£80-100

Anthony Crosier, probably a sea captain whose ship, Jonas' of Newcastle had been used in 1627 for the transport of the army of Mansfeldt but was lost on its return. Crosier claimed that he had lost £1100 in the service of James I and Charles I and had made unanswered orders of Charles for reimbursement. These complaints are echoed in this particular petition. Later, in 1628 Crosier was granted a prize ship, 'St Lawrence' in consideration of the loss of his own ship and his recent service at the siege of the ële de Ré.

Sir David Foulis

2019

1628 (1 December) receipt by Sir David Foulis, for £21 17s. 4d. received from "Sr. Adam Newton Kt & Barronett Receiver of our Revenues". Written on paper with small tears to the top left and bottom right. Paper has been mounted on a border of card at a later date. Signed "Da Foulis".

Sir David Foulis (-1642), 1st Baronet. Foulis was a Scottish politician who came to England with James I. In later years Foulis was dismissed from the council, fined and imprisoned for charges made against Wentworth as president of the North.

Sir Adam Newton (-1630), 1st Baronet. Newton was a Scottish scholar, Dean of Durham, and royal tutor to Prince Henry, son of James I, until 1610. After Henry's death, Newton became Receiver General or Treasurer in the household of Prince Charles I.

Francis Cottington

2020

1632 (5 May) Warrant from Francis Cottington as Chancellor of the Exchequer, to Robert Pye, Auditor of the Receipt, to make a debenture for £100 payable to Justinian Povey, Auditor of the Court of Exchequer. Paper mounted on card. Signed "Fra: Cottington".

Francis Cottington, 1st Baron Cottington (c. 1579-1652) was the English lord treasurer and ambassador and leader of the pro-Spanish, pro-Roman Catholic faction in the court of Charles I.

Henry Sandford

2021

1640-41 possibly incomplete certificate neatly written up on paper mounted on card, listing the fees of offices paid by Henry Sandford, Receiver General of Crown revenues in the counties of Kent, Surrey and Sussex, for the year XVI Charles I. Paper soiled. The first listed fee is that of Sir Humphrey Davenport, Chief Baron of the Court of Exchequer, for his work in examining the accounts of officials in these counties (£33 6s. 8d.). The next is for these three counties and Oxfordshire, Berkshire, Bedfordshire and Buckinghamshire, the most expensive fee listed. The list follows on with a fee for Henry Sandford himself and for various stewards.

Charles I

2022

1642 (28 June) LS to Robert Rich, 2nd Earl of Warwick as a "duplicate of our Revocacon of ye Eraunt of ye Office of Lord High Admirall of England", reiterating that Warwick is demanded to "give over and relinquish ye Command you have or pretend to have in any of our Ships of our Fleete, and forthwith to leave our Ship James, and our said Fleete to be commanded by such person as Wee have or shall appoint to take charge thereof ... it is no less then high Treason for any person whatsoever to deteyne any of our Shippes contrary to our expresse Commands". Signed "Charles R". Complete with address panel and filing endorsement to the reverse, paper reinforced in some places. A highly significant document, written under a month before the outbreak of the Civil War. Photo




£1,800-2,000

Robert Rich (1587-1658), 2nd Earl of Warwick was Lord High Admiral of the Navy as appointed by parliament as of letters of 1 July 1642 and earlier that year, against the King's will. In this letter just days later, the King's fear of Warwick's control over the Navy is clear. Notably, in 1648, Warwick retook the 'Castles of the Downs' at Walmer, Sandown and Deal where he became the Castle's captain. Warwick held the position of Lord High Admiral under the Parliamentarian force until the abolition of the House of Lords in 1649.









2023

Undated and incomplete letters consisting of three pages from Charles I to Treasury Commissioners, Treasurer and Under Treasurer of the Exchequer, and to Sir George Wentworth, Receiver of revenues from forfeited property of "popish Recusants & Papists" in the Northern counties. The letters state that:

The late Earl of Strafford (Thomas Wentworth, executed 11 May 1641) let the Crown in early 1640 a total of £20,000 (four tallies totalling £19,000 dated 31 January 1639-40 and another £1000 on 8 February), to be repaid at fixed dates in 1641-43 (£7000 in Easter Term 1641).


The late Earl by surrender of 19 April "*last*" (no later that 1641) gave up his letters of Privy Seal (9 May 1640) and all right and title in any capital and interest remaining to be paid; with request that what remained be payable to his brother Sir George Wentworth.

These letters confirm that Sir George Wentworth is to receive the sums due (£13,000 capital, and interest) to come out of moneys received by him and (if he is replaced in his office) by his successors. Photo

Sir George Wentworth (1609-66) joined his older brother, Thomas in Ireland (1633) where he was knighted by him. George sat in Irish Parliament of 1634 for Bandonbridge. He became MP for Pontefract 1640-44 but returned repeatedly to Ireland to support his brother in the charges against him.

2024 1651 copy of printed Act of Parliament "For continuing the Assessment of One hundred and twenty thousand pounds per Mensem for Six Months ... For Maintenance of the Armies in England, Ireland and Scotland" on two leaves. Photo

Commissioners for Sale of Land

1652 (27 October) a contemporary copy of a resolution by the Commissioners for removing obstructions, in lands and estates forfeited to the Commonwealth for treason, to be sold for the use of the Navy. Subscribed by Robert Aldworth, John Barners, Francis Mussended and William Roberts. Written in the same hand, on paper folded in the usual manner bearing a filing endorsement to the reverse. Paper frayed at ages with some soiling. The signatures copied here are given as "John Barners", "Ro: Aldworth", "William Roberts", "Fran: Mussoden". This resolution was written early in the life of the Obstructions Commissioners and documents its early methods of securing land to raise funds for the forces.

Abraham Granger

2026

1654 (c.) (1 January) petition of Abraham Granger to the Admiralty and Navy Commissioners neatly written on a single sheet of paper with light soiling to the edges and a small repair to the top and bottom left corners. Appears to have been written from confinement. Signed "A Granger". This petition mentions the favour Granger received from the Commissioners, which had given him not only his life but "encourageing hopes of Liberty". Granger then refers to a discovery of a delinquent's estate of £15,000, which he made "before hee was censured & suffered", and the fact that Colonel "Ven after my suffering would have had mee give & make out the discovery to him, which I refused.". He then protests that he has been his own accuser and has not hid any actions, even implicating his nearest friends and relatives, naming two of his own brothers, and "caused the apprehending of some of the Eminentest". He therefore requests his liberty, so that he be "enabled to goe on with his service propounded. Wherein hee doubts not, but to give such satisfacction as that most parte (if not all) of the Publique Faith debts wilbe paid, The Soldiers Arrears satisfied, The Treasures secured; And the offendors apprehended. And if your Honnours finde him false in a Tytle hee desires Death Without Mercy,". Petitions of this kind rarely bear a signature.

The Calendar of State Papers Domestic (1654-55) documents that Abraham Granger became embroiled in a massive swindle of the public funds of which Granger was found to be a leading figure. Granger had been accused in 1654-55 by Joshua Fugill of counterfeiting warrants and forging the signature of Navy and Admiralty Commissioners on them. Not only this, but Granger was accused of cheating the Commonwealth of £2000 through the manufacturing and vending of false coin. This document illustrates his efforts to free himself from confinement through the offering up of others for accusation and the portrayal of himself as an honest man. Granger's remaining history is uncertain. The last record of him states that he was still in prison 1655 (6 April) but since disappears from the index of the Calendar of State Papers Domestic.

2027

1654 (29 March) small sheet with minutes of a meeting. Signed by the clerk, "Rich: Lyndsy" in the reign of Oliver Cromwell.

Sequestration Commissioners



1654 (6 December), "A true copy" of the original document dated 1654 (7 February). Extracts from the accounts of the Sequestration Commissioners in Northumberland for 1650, 1651 and 1652. Written on paper folded in the usual manner bearing a filing endorsement to the reverse. Signed "T Bayly" in the bottom right. The entries concern the property of Lady Margaret Grey "Recusant" at "Spinleston & Outchester"; examined and subscribed by Daniel Hancocke, auditor. The property was let in the earlier accounts to Robert Dowdsworth and later to William Fenwick. The rent is stated, the sums received, and deductions are sometimes stated, for example "paid out in Repaires by Sr Arth: Heselriggs order 18-19-00".

Sir Arthur Hesilridge (1601-61), an English politician who sat in the House of Commons (1640-59). In the lead up to the English Civil War, Hesilridge was one of the five Members of Parliament whom King Charles I attempted to arrest in 1642.



Hamilton married Anne, Duchess of Hamilton (1632-1716) who had had her estate confiscated by Cromwell for which the Duke spent many years trying to rebuild from their losses. William Lenthall (1591-1662), known for serving the role of Speaker of the House of Commons and the Long Parliament from 1640. By 1659, Lenthall had become a figurative constitutional head of state during which time Generals George Monck and Richard Lambert tussled for power over Parliament. Lenthall's position of authority over Parliament became such that he was appointed the authority to sign military and naval commissions, making him the only Speaker to be granted such authority.

Henry Carey, 2nd Earl of Monmouth



Both he and his brother Sir Walter Pye, Attorney of the Court of Wards, attacked the Treasurer in 1624. Robert Pye supported the Royalist cause during the English Civil War and garrisoned his mansion at Farringdon only for it to be besieged by his own son, Robert who supported the Parliamentary cause. Sir William Morice (1602-76), English statesman and theologian, Lord of the Treasury (1660-68). Among the individuals named: Jervace (Gervase) Bennet (1612-), member of parliament who coined the term 'Quakers' to refer to the Religious Society of Friends. Lieutenant Colonel Robert Duckenfield (1619-89), during the Civil War, Duckenfield was known for defending Stockport Bridge against Prince Rupert, conducting the siege of Wythenshawe, commanding Parliamentary forces which captured the Isle of Man, and in this role, suppressing Sir George Booth's rebellion against Richard Cromwell. During his career Duckenfield became High Sheriff of Cheshire in 1649 and Governor of Chester in 1650.



A rare and early banking document, the first ever cheque written was in 1659.

Payment slips something like cheques probably existed in the ancient world, but in Britain the story goes back less far, to the birth of London's first banks in the mid-17th century. Those early bankers, mainly goldsmiths and scriveners, wanted to make payment processes easier and less risky. They developed a way for customers to make payments using paper instructions, leaving their gold and silver safely tucked up in the vaults. In so doing, they gave ordinary citizens access to a service previously available only to international merchants through bills of exchange. Sir John Lewys was a London merchant and ship owner who made his fortune in the East Indies in Persia. He was made an alderman in 1656. He married Sarah Foot, the third daughter and co-heir of Sir Thomas Foot, in 1654. His father-in-law, Sir Thomas Foot, was a London merchant who had been Lord Mayor of London 1649/50.

In 1662 Mordaunt was put in command of the Tangier Regiment with varying success. In 1687 Mordaunt became a Roman Catholic and was impeached for high treason.





Anthony Ashley Cooper, Ist Earl of Shaftesbury (1621-83) was a prominent English politician, also known for his patronage of the theologian, John Locke. Cooper, around the time of signing this warrant had opposed Sir George Downing's proposal that money rasied for the King should only be used to fund war efforts; Cooper argued for greater freedom, eventually coming to blows with Charle's Lord Lieutenant of Ireland over the matter. Further, Thomas Clifford (1630-73), as Treasurer of the Household, had been negotiating the Treaty of Dover with France. The Treaty garnered support from the French in opposing the Dutch in return for the King's conversion to Roman Catholicism - a clause that Cooper had been ignorant of.

In a similar political move, Cooper joined the Cabal Ministry - a group of high councillors of Charles II across the Kingdom designed to avoid royal favouritism.

Alderman Edward Backwell (1618-83) English goldsmith banker and later politician often named as founder of the banking system of England. Figures such as those mentioned in this warrant go some way to explaining how the Stop of the Exchequer in 1672 almost put an end to his business.



Teller's Bill

1670, two Teller's bills for the collection of tax for the King's subscription. The first being received from John Colvile as part of a loan from the farmers of Customs and Subsidies of £16,000, the second being received from Sir John Wolstenholme, Sir John Shaw and Sir Robert Wyyner Baronets, Sir Edmund Turnour Knight, Edward Backwell and Francis Millington for £270 as part of payment due from the farm. Both signed "Jo Loving". Bills written out on short, wide pieces of paper, folded vertically down the middle with the top and bottom punctured by regular and small holes.

The role of the 'farmers' mentioned above was to collect tax and make payments of regular sums to the government. Whatever tax they collected over a set sum was their profit. These men became extremely prominent and powerful figures in finance as goldsmiths and bankers. All suffered badly after the Stop of the Exchequer.



Stop of the Exchequer 1672 (January) saw a freeze on all payment from the Exchequer for 12 months after the debt of crown became too great owing to the Naval efforts against the Dutch and the current fiscal policies of Charles II. The Stop had a disastrous effect on the goldsmith bankers who had loaned vast sums to the crown.


Sir Thomas Osobrne and Sir Thomas Littleton were joint Treasurers of the Navy who had been the subject of a discussion regarding outstanding orders from them, of which it was noted there were still several unpaid.

"My Lord Brouncker" - William Brouncker, 2nd Viscount, was a mathematician, became the first President of the Royal Society and Navy Commissioner at the time of this memorandum.





An interesting document illustrating the King's lenience in the collection of taxes through farm fees.

Henry Jermyn (1605 (baptised)-1684), English politician, Earl of Saint Albans and Baron Jermyn (1625-43), was Charles I's Vice Chamberlain from 1628 and Master of the Horse from 1639. Jermyn was active in garnering support for the Crown from abroad, acting for a short while as Henrietta Maria of France's secretary. Henry Jermyn is also acknowledged as the 'Father of the West End', owing to areas of St James's Square and surrounding streets being granted to him. The sites were later cleared to build Regent Street and Waterloo Place.

During the late 17th century, Bennet was accused of having taken irregular charges in the Post Offices, a claim that saw him ordered by Laurence Hyde, as Lord Treasurer, to refund £12,375.

Nathaniel St Andre

Nathaniel St André (c.1680-1776) was born in Switzerland and came to England as a boy servant with a rich family. Being proficient in languages, fencing, music and dancing, he initially made his living as a teacher. He later trained as a surgeon and anatomist, eventually becoming anatomist to the royal household of George I in 1723. He numbered amongst his other clients Alexander Pope and Samuel Molyneux, MP. His medical reputation, however, received a near fatal blow in 1726 when he was duped by the infamous Mary Toft of Godalming, who claimed to have given birth to rabbits. St Andre was sent by the court to investigate these incredible claims and was somehow completely deceived by her. He was subsequently ridiculed (by Hogarth amongst others), discredited and lost his position at court.

He nevertheless continued to prosper and in 1730 he married Lady Elizabeth Capel, the eldest daughter of the Earl of Essex, who possessed a large fortune in her own right. She had previously been married to Samuel Molyneux, who had died suddenly on the floor of the House of Commons in 1728. Lady Elizabeth and St Andre eloped together on the night of her husband's death, and as Molyneux was a patient of St Andre's there were even suggestions that he had hastened his death.

From around 1742 St Andre was living in a town house, adjoining the Dolphin Hotel on the High Street. He later bought the house and the hotel, both of which he considerably improved and enlarged. He was in his eighties when he designed and created Bellevue House which was completed by 1768. It is not clear that he ever lived at Bellevue, having still the High Street house and a London residence in Hanover Square. He purchased Banister Court just before his death in 1776. He was buried in St Mary's churchyard and some of his properties were sold at auction in the July of the same year. He had two illegitimate sons - George Frederick and William Henry - by his maid servant Mary Pitt, to whom he left the bulk of his estate, including his library which later became the core of Southampton's first public library.

In Ramsay's letter of the 21st of January 1913 sent from 19, Chester Terrace, Regent's Park, N.W. London he cites in English a previous letter of his that denies his association with the scheme. "Sir, my attention has been called to the fact that I have been said to have published a favourable report on a supposed process for manufacturing gold artificially, and that shares are being disposed of by a French or Belgian syndicate on this rumour; I therefore ask you to be good enough to allow me to state that I have published no such report; and that it appears to me in the highest degree improbable (although as a scientific man I should


Antarctic Wilkins Expedition

c.1929-30 two red cloth-bound diaries (10x16cm) written in pencil over 114 pages by the Chief Engineer aboard the RRS William Scoresby, a British research ship that operated in Antarctic waters as part of the Discovery Investigations, recording biological, oceanographic and hydrographical studies. This ship also participated in the 2nd Wilkins-Hearst Antarctic Expedition (1929-30), launching a Lockheed Vega floatplane for flights over Antarctica. Accompanied by 35 original photographs of the ship in ice, the floatplane both on deck and off, views near Deception Island, the post office at Grytviken, South Georgia, whaling, Copper Mountain, De Gerlocke Straits, Shags - Port Lockroy, Joey the Antarctic cat and others, many captioned. 10 October - today we leave Simonstown for S. Georgia. 14 October - we towed some nets and caught a lot of stuff which the scientists think a lot of. Never knew there was such muck in the sea. 20 October - blowing with a high confused sea and swell. We had our first shower of snow, hail and sleet. 21 October - sighted one iceberg and 4 killer whales 22 October Wind is 150 miles per hour, sea is a fury. Cat had kittens today, four, One died, one she laid on, one fell in the milk and got drowned. 28 October - at 3pm arrived at Grytviken 30 October - went for a walk to Shackleton's cairn but snow was too sloppy. 8 November - Sir H Wilkins has been here and has gone on in the factory ship Melville and we follow. 12 November - Station Working (description of taking soundings, related activity, pencil illustration) 16 November - the position of Graham's Land is miles and miles out. 17 November - making for Deception Island 19 November - loading up penguin eggs in a box on the sledge. Photography was out of the question as I could only see a few feet ahead. 24 November - no news yet about Wilkins start. Planes are being tested. 26 November - Wilkins aeroplane went up for a spin but on landing busted the tail landing show. Hard luck. 28 November - left Deception Island and went for a cruise round the islands to take bearings and correct the positions of some on the charts. 1 December - seal hunting 10 December - Melchior Island; saw an iceberg split - tremendous roar was deafening 11 December in and out of the islands. The scenery is marvellous. Ice cliffs covered with penguins. The copper mountains and glazier are beyond an ordinary description. Arrived at Port Lockray; only used for whaling. 12 December - painted ships name on rock and also "Wilkins Expedition" on another. 14 December - sighted Adelaide Is. Getting near the end of the world now. 20 December - Wilkins is worried; has found the ice is melting fast and is unsuitable for taking off. I have snow blindness. 21 December - have run right down to Charcot Island and got in the pack ice 24 December - Xmas Eve. Cold, snowing, blowing, overcast, gloomy 27 December - Sir H. Wilkins reported heavy snowstorms and had to return. Tucked the plane up to bed. 28 December - chased 3 large blue whales and tried to mark them by shooting our little darts into them. No good though, they "sounded" and went under the ice. 1 January - Happy new year, Dorothy. No luck today with flight. 2 January - been an earthquake at Deception Island 4 January - entered the Neumeyer Channel where we put the plane in the water. 6 January - not going to New Zealand but to Stanley and back to Deception Is. Pick up Wilkins and plane and go south. 18 January - went aboard Discovery 11 for dinner. 30 January - Lat. 70 05 3 Long 100 32W I don't suppose more than 2 other ships have ever been down here. 1 February sighted emperor penguins as big as men. Fossil specimens have been found. 8 February the W/T operator overheard a message from Stanley that Deception Is has wire home to Colonial Office and press that they fear the worse, as no news of the William Scoresby. Of course we are in a place never visited before. 12 February - Wilkins wants to catch a ship to Monte Video so we are making a burst for it. Weather is bad. 13 February - tomorrow morning we hope to be in Deception Is and get rid of our friends. 14 February - at 10am got into Deception where we discharged the plane and then went alongside the "Hendrik Ibsen" bound to Monte Video. We discharged all his gear on board and then they pushed off. So that is the finish of the expedition. I'm rather disgusted about the finish of the whole business. Wilkins has evidently played for the press. We leave here on Monday for Stanley where we have a spell, I think. So now Dorothy this awful diary will cease. Chorus : Thank Goodness. Photo

Hawley Harvey Crippen (1862-1910) usually known as Dr. Crippen, was an American homeopath, ear and eye specialist and medicine dispenser. He was hanged in Pentonville Prison in London for the murder of his wife Cora Henrietta Crippen, and was the first suspect to be captured with the aid of wireless telegraphy. In 1897, Crippen transferred to England with his wife, although his US medical qualifications were not sufficient to allow him to practise as a doctor in the UK, as Crippen continued working as a distributor of patent medicines.







King Ludwig came to power in 1825, after inheriting the throne from his father. Following the July Revolution in France in 1830, Ludwig enacted a series of repressive policies, which proved unpopular. Coupled with his wanton spending and love of womanising, Ludwig rapidly fell out of favour with his subjects. Known also for his affair with the Irish dancer Lola Montez. This intense affair caused great outrage, and in 1848, with revolution sweeping across Europe, matters came to a head. On March 4, the Royal Residence was stormed. Ludwig's brother, Prince Karl, succeeded in heading off the crisis, but his own family and ministers then turned against Ludwig, forcing him to sign a concessionary proclamation. The proclamation, dated on 6 March, promised far-reaching political reforms and civil liberties, but in the end it all proved too much for King Ludwig. On 20 March 1848, he abdicated in favour of his oldest son, Maximilian II, claiming that he was unwilling to rule under such constraints.



On the night of the 3rd September 1916 the war arrived in a very real way to the small village of Cuffley. A Schutte-Lanz airship SL-11 (a wooden airship which was lighter than a Zeppelin) was on a bombing raid over London and was successfully attacked by 2nd Lieutenant (later Captain) William Leefe Robinson of the 39th Home Guard Squadron. His small biplane used a new type of incendiary ammunition to set the ship alight. SL-11 came down to earth behind the Plough Inn at Cuffley. The entire 15 man crew was killed. It became the first airship shot down on British soil and Leefe Robinson was awarded the Victoria Cross for his actions. A memorial stands on the sight of the crash today.

KINGDOM OF THE TWO SICILIES

The following section comprises letters from Monarchs and their Consorts of Great Britain and France to the Kingdom of Two Sicilies during the period 1743-1850. Most notable are the letters from King Louis XVI and Queen Marie Antoinette of France to King Ferdinand I of the Two Sicilies. These represent the personal efforts of European royals in danger to bolster their divine right to power. Written in 1790, the ink dried as the French Revolution ignited; the King and Queen were under house arrest at the Tuileries and likely already dreaming of their ill-fated escape to Varennes in 1791 under cover of a summer night. In 1792 the French Monarchy was abolished and in 1793, the King and Queen were executed.


Wife of King Ferdinand I, Queen Maria Carolina, was sister to Marie Antoinette and greatly distressed by the progress of the Revolution in France. The three marriages mentioned by King and Queen in this pair of letters between Franz Joseph of Hapsburg-Lorraine and Maria Theresa of Naples, Ferdinand III, Grand Duke of Tuscany and Luisa of Naples and Sicily, and Francesco I di Borbone and Maria Clementina Guiseppe Giovanni Fedele of Habsburg-Lorraine were very much the result of Maria Carolina's careful planning.

The letters themselves and the marriages and relationships they refer to strengthened European ties marking a continuing and intensifying alliance between the Kingdom and Two Sicilies, Austria and later Britain united against the forces of Napoleon Bonaparte throughout the 18th and 19th century.

Slatin spent eleven years captive under the Mahdists until he escaped over a 1000km, three week journey across the desert to Aswan, Egypt in 1895.







A comprehensive correspondence from Bertram Henry Samuel Romilly (brother-in-law of Sir Winston Churchill) (29) from 1904-09 from his posting in the Sudan as Colonel in the Egyptian Army Camel Corps. All letters are addressed to his Father, come accompanied by their original cover and are written on Sudan Camel Corps or IX Sudanese headed letter paper where available. Correspondence includes: 1904 (30 August) ALS from Foga mentioning that "I'm in an extraordinary place, the only Englishman, arrived two days ago after eight days on a camel, found most of No. 1 Company of the Camel Corps going on very comfortably under the command of an Egyptian Captain". With cover carried by camel to Nahud where it was postmarked. 1905 (10 April) ALS written from El Odliya with rough ink drawing illustration of a "mud-hut" indicating where the doors are located. With cover bearing 1p. cancelled at El-Obeid - the destination of his 6 day journey mentioned in this letter. 1905 (19 May) ALS written from the Camel Corps at Nahud. Letter is pre-empted by fine drawings of trophies from his hunting expeditions including the skulls of a "Hartebeeste", "Ril" and "Tiang". With cover bearing 1p. cancelled by Nahud c.d.s. 1906 (June) two ALS, one from El Oheid (2 June) the other from Gebel Kadugli (9 June) concerning the battle at Talodi "El Obeid ... returned here day before yesterday ... Too busy to write much - anyhow I can't as it's all Confidential" going on to write "Gebel Kadugli ... you probably know by now that we had a Post cut up by Arabs at Talodi. Two Egyptian officers murdered ... we hope to get a chance of going for these fellows & taking blood for blood, in order to re-establish prestige ... Nubas from the mountains & Arabs are helping in hunting these fellows". With envelope bearing 5m cancelled by very fine and rare dotted retta cancel introduced for security reasons. 1909 (20 February) ALS written from Bara explaining to his father that he had been mentioned in Despatches for leading the Nyima Patrol mentioning also that he is "giving a delenka [native dance] next Thursday in commemoration of the Nyima Patrol". You are requested to contact us by telephone or in person as soon as possible after the auction to obtain details of the outcome of your bids to avoid incurring charges for late payment.

- Packing and handling
 5.8.1 We shall use all reasonable endeavours to take care when handling and packing a purchased Lot but remind you that after seven days or from the time of collection, whichever is sooner, the Lot is entirely at your risk. Our postage charges are set out at the back of the catalogue
- 5.8.2 It is the responsibility of the Buyer to be aware of any Import Duties that may be incurred upon importation to the final destination. Spink will not accept return of any package in order to avoid these duties. The onus is also on the Buyer to be aware of any Customs import restrictions that prohibit the importation of certain collectibles. Spink will not accept return of the Lot(s) under these circumstances. Spink will not accept responsibility for Lot(s) seized or destroyed by Customs.
- 5.8.3 If the Buyer requires delivery of the Lot to an address other than the invoice address this will be carried out at the discretion of Spink.

Recommended packers and shippers

If required our shipping department may arrange shipment as your agent. Although we may suggest carriers if specifically requested, our suggestions are made on the basis of our general experience of such parties in the past and we are not responsible to any person to whom we have made a recommendation for the acts or omissions of the third parties concerned.

5.10 Remedies for non-payment or failure to collect purchases

- 5.10.1 If you fail to make payment within seven days of your stipulated payment date set out in your invoice, we shall be entitled to exercise one or more of the following rights or remedies:
 - 5.10.1.1 to charge interest at the rate of 2% per month compound interest, calculated on a daily basis, from the date the full amount is due;
 - 5.10.1.2 to set off against any amounts which the Spink Group may owe you in any other transaction the outstanding amount remaining unpaid by you;
 - 5.10.1.3 we may keep hold of all or some of your Lots or other property in the possession of the Spink Group until you have paid all the amounts you owe us or the Spink Group, even if the paid all the amounts you owe us or the Spink Group, even it the unpaid amounts do not relate to those Lots or other property. Following fourteen days' notice to you of the amount outstanding and remaining unpaid, the Spink Group shall have the right to arrange the sale of such Lots or other property. We shall apply the proceeds in discharge of the amount outstanding to us or the Spink Group, and pay any balance to you;
 - 5.10.1.4 where several amounts are owed by you to the Spink Group in respect of different transactions, to apply any amount paid to discharge any amount owed in respect of any particular transaction, whether or not you so direct;
 - 5.10.1.5 to reject at any future auction any bids made by you or on your behalf or obtain a deposit from you before accepting any bids.
- 5.10.2 If you fail to make payment within thirty-five days, we shall in addition be entitled
 - 5.10.2.1 to cancel the sale of the Lot or any other item sold to you at the same or any other auction;

- 5.10.2.2 to arrange a resale of the Lot, publicly or privately, and, if this results in a lower price being obtained, claim the balance from you together with all reasonable costs including a 20% seller's commission, expenses, damages, legal fees, commissions and premiums of whatever kind associated with both sales or otherwise, incurred in connection with your failure to make payment:
- 5.10.2.3 when reselling the Lot, place a notice in our catalogue stating that you successfully purchased the Lot at auction but have subsequently failed to pay the Hammer Price of the Lot; or
- 5.10.2.4 take any other appropriate action as we deem fit.
- 5.10.3 If you fail to collect within fourteen days after the sale, whether or not payment has been made, you will be required
 - 5.10.3.1 to pay a storage charge of £2 per item per day plus any additional handling cost that may apply.
 - 5.10.3.2 you will not be entitled to collect the Lot until all outstanding charges are met, together with payment of all other amounts due to us.

5.11 Use of Default Information

If you fail to make payment for a Lot in accordance with these Terms and Conditions:

- 5.11.1 we reserve the right to refuse you the right to make bids for any future auction irrespective of whether previous defaults have been settled; and
- you acknowledge that we may (as necessary for our legitimate interests those of other auctioneers and live bidding platforms in 5.11.2 referencing customers and avoiding customer defaults) disclose details of such default to other auctioneers and live bidding platforms, which will include your name, address, nature of the default and the date of the default.

Auctioneers or live bidding platforms who receive details of the default may rely on such information when deciding whether to enter into a transaction with you in the future.

5.12 Export Licence

- 5.12.1 If required we can, at our discretion, advise you on the detailed provisions of the export licensing regulations. Where we advise you in relation to export licensing regulations the ultimate responsibility in respect of any export will lie with you and we will not be responsible for your failure to apply for any necessary licences.
- 5.12.2 If the Lot is going to be hand carried by you, you may be required to produce a valid export licence to us or sign a waiver document stating that a licence will be applied for.
- 5.12.3 You should always check whether an export licence is required before exporting. Export licences are usually obtained within two or three weeks but delays can occur.
- 5.12.4 Unless otherwise agreed by us in writing, the fact that you wish to apply for an export licence does not affect your obligation to make payment within seven days nor our right to charge interest on late payment.
- 5.12.5 If you request that we apply for an export licence on your behalf, we shall be entitled to recover from you our disbursements and out of pocket expenses in relation to such application, together with any relevant VAT.
- 5.12.6 We will not be obliged to rescind a sale nor to refund any interest or other expenses incurred by you where payment is made by you despite the fact that an export licence is required.

5.13 Refund in the case of Forgery

- 5.13.1 A sale will be cancelled, and the amount paid refunded to you if a Lot (other than a miscellaneous item not described in the catalogue) sold by us proves to have been a Forgery. We shall not however be obliged to refund any amounts if either (a) the catalogue description or saleroom notice at the auction date corresponded to the generally accepted opinion of scholars or expert at that time of circle individual that there were conflict of experts at that time, or fairly indicated that there was a conflict of opinions, or (b) it can be demonstrated that the Lot is a Forgery only by means of either a scientific process not generally accepted for use until after publication of the catalogue or a process which at the date of the auction was unreasonably expensive or impracticable or likely to have caused damage to the Lot.  - 5.13.1.3 as soon as possible following return of the Lot, you must produce evidence satisfactory to us that the Lot is a Forgery and that you are able to transfer good title to us, free from any third party claims.
 - 5.13.1.4 you must provide to us all evidence obtained by you that a Lot is a Forgery no later than 7 days after you receive such evidence.
- 5.13.2 In no circumstances shall we be required to pay you any more than the amount paid by you for the Lot concerned and you shall have no claim for interest.
- 5.13.3 The benefit of this guarantee is not capable of being transferred, and is solely for the benefit of the person to whom the original invoice was made out by us in respect of the Lot when sold and who, since the sale, has remained the owner of the Lot without disposing of any interest in it to any third party.
- 5.13.4 We shall be entitled to rely on any scientific or other process to establish that the Lot is not a Forgery, whether or not such process was used or in use at the date of the auction.

6 LIABILITY

Nothing in these Terms and Conditions limits or excludes our liability for:

- 6.1 death or personal injury resulting from negligence; or
- 6.2 any damage or liability incurred by you as a result of our fraud or fraudulent misrepresentation.

7 USE OF YOUR PERSONAL INFORMATION

- 7.1 We will use the personal information you provide to us as set out in our privacy notice (available at https://spink.com/privacy-policy) and in particular to:
 - 7.1.1 process the bids you make on Lots (whether successful or otherwise) and other auction related services we provide;
 - 7.1.2 process your payment relating to a successful purchase of a Lot;
 - 7.1.3 arrange for delivery of any Lot you purchase, which will include passing your details to shipping providers and, on overseas deliveries, to customs where they make enquiries regarding the Lot;
 - 7.1.4 inform you about similar products or services that we provide, but you may stop receiving these at any time by contacting us.

- 7.5 Where you provide us with personal information about other individuals, you must ensure that your provision of that information is compliant with applicable data protection law.

8 COPYRIGHT

- 8.1 We shall have the right (on a non-exclusive basis) to photograph, video or otherwise produce an image of the Lot. All rights in such an image will belong to us, and we shall have the right to use it in whatever way we see fit.
- 8.2 The copyright in all images, illustrations and written material relating to a Lot is and shall remain at all times our property and we shall have the right to use it in whatever way we see fit. You shall not use or allow anyone else to use such images, illustrations or written material without our prior written consent.

9 VAT

You shall give us all relevant information about your VAT status and that of the Lot to ensure that the correct information is printed in the catalogues. Once printed, the information cannot be changed. If we incur any unforeseen cost or expense as a result of the information being incorrect, you will reimburse to us on demand the full amount incurred.

10 NOTICES

All notices given under these Terms and Conditions may be served personally, sent by 1st class post, or faxed to the address given to the sender by the other party. Any notice sent by post will be deemed to have been received on the second working day after posting or, if the addressee is overseas, on the fifth working day after posting. Any notice sent by fax or served personally will be deemed to be delivered on the first working day following despatch.

11 ADDITIONAL PROVISIONS

The following provisions of this clause 11 shall apply only if you are acting for the purposes of your business.

11.1 Limitation of Liability

Subject to clause 6, we shall not be liable, whether in tort (including for negligence) or breach of statutory duty, contract, misrepresentation or otherwise for any:

- 11.1.1 loss of profits, loss of business, depletion of goodwill and/or similar losses, loss of anticipated savings, loss of goods, loss of contract, loss of use, loss of corruption of data or information; or
- 11.1.2 any special, indirect, consequential or pure economic loss, costs, damages, charges or expenses.

11.2 Severability

If any part of these Terms and Condition is found by any court to be invalid, illegal or unenforceable, that part may be discounted and the rest of the conditions shall continue to be valid and enforceable to the fullest extent permitted by law.

11.3 Force majeure

We shall have no liability to you if we are prevented from, or delayed in performing, our obligations under these Terms and Conditions or from carrying on our business by acts, events, omissions or accidents beyond our reasonable control, including (without limitation) strikes, lock-outs or other industrial disputes (whether involving our workforce or the workforce of any other party), failure of a utility service or transport network, act of God, war, riot, civil commotion, malicious damage, compliance with any law or governmental order, rule, regulation or direction, accident, breakdown of plant or machinery, fire, flood, storm or default of suppliers or subcontractors.

11.4 Waiver

- 11.4.1 A waiver of any right under these Terms and Conditions is only effective if it is in writing and it applies only to the circumstances for which it is given. No failure or delay by a party in exercising any right or remedy under these Terms and Conditions or by law shall constitute a waiver of that (or any other) right or remedy, nor preclude or restrict its further exercise. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that (or any other) right or remedy.
- 11.4.2 Unless specifically provided otherwise, rights arising under these Terms and Conditions are cumulative and do not exclude rights provided by law.

11.5 Law and Jurisdiction

- 11.5.1 These Terms and Conditions and any dispute or claim arising out of or in connection with them or their subject matter, shall be governed by, and construed in accordance with, the law of England and Wales.
- 11.5.2 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, Terms and Conditions or their subject matter.
