

Foreword

There can be many reasons that spark a person's interest in collecting. For me it was when my father gave me three banknotes from the 1940's - a 10/-, £1, and £5. They were not rare (neither were they in particularly good condition) but when I looked hard at them I was struck by the beautiful and amazing artwork. Little did I realise then that they would begin a journey lasting nearly 4 decades during which I would assemble some of the rarest and most desirable British banknotes.

My collection started in earnest in 1983 when I visited Spink for the first time and met the Director of the Banknote Department the enigmatic Barnaby Faull. The "hobby" was then in its infancy, but as luck would have it Barnaby had just received a small collection from an ex-governor of the Bank of England. It contained many gems including the first ever 10/- note and the incredibly rare Portsmouth £100 specimen...these notes, amongst



many others, led me to put together what Barnaby describes as: "Not the biggest - but certainly the rarest and best condition collection – extant today"!! You will judge for yourselves. In conclusion I will say that I have had enormous pleasure and satisfaction in putting these little treasures together and to any successful bidders - I can only wish you the same joy.

Foreword

I started in the Banknote Department over three decades ago and one of my first clients in those far-off days was Lou.

Lou came in to buy a black-and-white fiver, ('The Horseblanket') purely for nostalgia and simply because he liked them. His arrival coincided with the appearance of a particularly good collection of Bank of England and Treasury notes and, as I obviously must have spun a good tale, Lou soon became the owner of some very good banknotes. At that stage in my banknote career it was a case of the blind leading the blind, but both of us could see that there were some very special notes in that collection: the first-ever 10 shilling note produced by the Treasury with the number A/1 000001; a Portsmouth branch Nairne 100 pound note; magnificent trials of notes 'that never were' and so on...

This was the start of a wonderful collection: Lou's eye for quality is superb as witnessed by his concurrent collections of coins, stamps and wine - all top of the range in their fields. Over the years those collections have gone but the banknotes were (I would like to think) his favourite collection and have been retained up till now, long after everything else. Lou has added many fine examples over the last few decades, and in fact he almost certainly has the largest assembly of top-quality notes outside of a museum or private institution.

I know Lou has enjoyed the experience and I can genuinely say that he has always been a pleasure to deal with - in fact I can easily describe Lou as the most relentlessly cheerful client I have ever met. What Lou says of me in return is not for publication! I hope the catalogues (Part I and II) will do justice to the belief and passion that Lou has put into this superb assemblage: I've no doubt our clients will be delighted to own his notes and to point out that they have something 'ex-Lou Manzi Collection' - a provenance to be proud of.
