

"Four things our Noble sheweth me, King, ship, and sword, and power of the sea"

An excerpt from the manuscript library of Sir Robert Bruce Cotton (1571–1631)

Spink is delighted to present the Isladulcie collection, and in so doing bring to market one of the more comprehensive assemblages of Medieval English gold coins to appear in recent years. In certain reigns its focus is stronger than even that witnessed in the late Lord Stewartby's sales through this house in 2016 and 2017.

In the following pages you will find a veritable corpus for this 'sceptred isle' spanning the duration of the Hundred Years War, from the infancy of regular gold coinage in England in the 1340s, through to its retariffing and eventual replacement by the *"Angel-Noble"* under Edward IV. Originally borne out of a backdrop of growing international trade into the kingdom, alongside the necessity for Italian loans to fund Edward III's ongoing war with France, it was resolved that England should produce its own domestic gold coinage. Following decree of Parliament dated 27 January 1344, the now infamous "Double Leopard" and its fractions were introduced. Lasting all of seven months (First Period), its tariffing at Six Shillings to align with gold Florins grossly exceeded its intrinsic content, fatally undermining consumer confidence in the coinage with traders and eventually prompting a total recall by August.

Recoinage then occurred (Second and Third Periods), inspired by another pre-existing unit of account – the mark [160 pence] as well as the contemporary French écu valued at 40 pence. Shortly followed the *"Noble, maile-Noble"* and *"ferling-Noble"* valued at 6s8d [80 pence], 3s4d [40 pence] and 1s8d [20 pence] respectively. Equally inspired was the imagery used on this latest coin: the King armoured, brandishing sword and Royal shield, surmounting a ship on the obverse, and the floriate cross juxtaposed with heraldic leopards, crowns and lys on the reverse. Overtly militarised in symbolism, this was a blatant allusion to Edward's and by extension England's recent naval victory over their French adversaries at the Battle of Sluys in June 1340. Consideration was also made of the accompanying legends, dispensed with were the traditions of a mint signature or a moneyer's name, instead replaced by penitential psalms familiar to any Christian living in Medieval England. Evidently not only were these coins destined to be a guarantee of economic value, but an invocation to Christ to safeguard the religious health of every Englishman who used them. Satisfactory supply would ensure the survival of these coins and its revolutionary iconography for the next century with little alteration.

During this time, the striking of gold remained typically the preserve of the mint cited at the Tower of London, but following the Treaty at Brétigny, Calais was also commissioned to strike the coins with their own distinguishing characteristics. The most typical differentiating mark from the London issues was the re-positioning of the flag at the stern castle or with the inclusion of a motif above the shield on the smallest denomination. Similarly York, and later Bristol and Norwich were also occasionally re-employed to strike gold; a solid representation of these 'provincial pieces' you will no doubt be pleased to read also grace this sale.

It will, however, become readily apparent that the great strength of this collection lies in its offering of Edward III. No fewer than forty-four issues assist us in decoding this notoriously complex series to which the likes of L A Lawrence, G V Doubleday and also C A Whitton have formerly dedicated their interests. However, a certain pride may also be drawn from the subsequent 'discussion' over the transitional phase of issues struck following the reformation of weight standards in 1412 (see lots 61-66). Stewartby has latterly advanced the idea that class A and B coinages, traditionally ascribed to the reign of Henry V, should be reviewed in the context of this recoinage, a view to which the vendor lends his hearty support.

Ultimately this collection frames perhaps the most dramatic and important development in the long and illustrious history of English numismatics. From the successful introduction of a regular circulating gold coin of the realm, to the adoption of an universal iconography reflective of the growing sense of nationhood amongst her peoples hitherto unrepresented in such splendour. The majesty of her warrior King is plain for all to see, but the awakened spirit of the English kingdom is the reason for his pride.

EDWARD III (1327-1377)

Third 'Florin' Coinage (1344-1351)

Third Period [1346-1351]


This coinage frames the "chevauchée of Edward III" - a series of significant English military victories over the ruling French house of Valois in 1346. Employing his formidable arsenal of longbowmen, Edward began his campaign with the sacking of Caen [26 July], before triumphing at the battles of Blanchetaque [24 August]; and more famously Crécy [26 August]; before repulsing an invading French force at Neville's Cross near Durham [17 October], and finally the besieging and capture of Calais in August 1347. Minor contemporary skirmishes also occurred at this time, resulting in further English victories, such as during the Breton War of Succession against Charles of Blois at La Roche-Derrien [1347] and over the Castillians at the naval battle of Winchelsea in August 1350.

Fourth Coinage (1351-1377)

Pre-Treaty Period [1351-1361]

This significant coinage covers a reduction in military activity across the Channel with only minor skirmishes resulting in small French victories at the siege of Saint-Jean-d'Angély {Feb-Aug. 1351}, Ardres {6 June 1351}, and Montmuran {1354}; and similarly small English military victories at Mauron {14 August 1352}, and Comborn {1353}. However the opposing armies once again met on 19 September 1356 on the fields of Nouaillé, near Poitiers. The result was a decisive victory for the English, with Edward the Black Prince capturing not only the French king Jean II, but also his son and most of the ruling nobility. Seeking to capitalise on the chaos now enveloping the French kingdom, King Edward sought to capture Rheims and Paris. Unsuccessful in these sieges, he moved his army to Chartres and agreed to open treaty negotiations with the French dauphin Charles at Brétigny in April 1360.

"The Trial of the Pyx, or the assembly of judges commissioned to regularly affirm the purity and weight standard of the coin of the realm, is recorded as meeting on a quarterly basis during this period, setting a precedent for the subsequent reigns of the Plantagenet dynasty. Pipe rolls indicate that in the facilitation of this important appraisal, comptrollers were duty bound to make: "une prive signe en toutes les monoies" [gold and silver] produced by them. L A Lawrence in his definitive study of the Edwardian coinage explored possible marks encountered throughout the series but concluded that any additional mark such as the lys appeared too frequently to be such a defining mark. Potter subsequently deduced that any such marks ought not to have been necessary, owing to the procedures, checks and balances involved in the Pyx trial, pointing to a similar absence across the more extensive contemporary silver coinage.

The trove of no fewer than ninety-nine Edward III and Richard II gold Nobles was discovered by farmer Ronald Stocker and friend Malcolm Dennis in an onion field near the village of Surfleet, Lincolnshire over the course of several seasons beginning with an isolated find in 1983. Following guidance from the British Museum upon identification of this first find as a series G Noble of Edward III's pre-Treaty [fourth] coinage, and with the discovery of a further five coins in 1985, a more extensive search was organised for late September 1986. Over the course of two weekends a further eighty-seven coins were recovered, sixty of which were reportedly found in close association to one another as if originally stacked together. Over the Valentine's weekend of 1987 a further six coins were recovered and brought to Coroner's inquest with the previous discoveries on 16 June 1987. Promptly declared treasure, 23 coins were retained at a cost of £11,860 for the national collection, the remainder were consigned to auction with Christie's.





Transitional Treaty Period [1361]

Following the ratification of the Treaty of Brétigny in October 1360, Edward renounced his claim to the French throne in trade for the expansion of his territories in Aquitaine, prompting him to restyle as 'Lord' of this new principality. Both of these events would subsequently be reflected on the coinage. A King's ransom was set for the return of Jean II at three million écus, with one million required for his release on bond. The ransom prompted the introduction of the 'Franc', a distinctive issue with the French king on horseback weighing slightly more than a contemporary Half-Noble. The Mint master for the pre-Treaty coinage, Walter dei Bardi is identified by Potter and latterly Stewartby as the likely comptroller for this issue, identifying a small window of striking prior to dei Bardi's resignation from office in June 1361.

Treaty Period [1361-1369]

Regional hostilities continued during this period, with Edward, the Black Prince embroiling himself in the Castillian and Breton Wars of Succession. His proxy campaigns favoured Pedro I over half-brother Henry II, who was accordingly supported by Bertrand du Guesclin, the constable of France under Charles V. The sides met at Cocherel on 16 May 1364, resulting in a minor defeat for Edward. However the Black Prince was soon avenged at Auray [29 September 1364], routing the French battle line, and in the process claiming the strategic bragging rights of having captured du Guesclin himself. Pedro once more relied on the assistance of the Black Prince's forces at Nájera [3 April 1367]. However the victory was decidedly pyrrhic for Edward, for Henry II had escaped, only serving to galvanize his appeal amongst the Castillian nobility. Worse still, Pedro could not afford to pay back the costs of his hired mercenary army. As a consequence, the Black Prince was forced to levy a tax on his Gascon nobles. Understandably disaffected, his noblemen made discrete approaches to Charles V. The French king entirely aware of the consequences of affecting his own sovereignty over the English-held Aquitaine, not just on the Treaty of Brétigny, but on wider relations between the two kingdoms weighed his decision on the basis of Henry II's surviving claim to the Castillian crown. Calculating that an alliance with Castille would enable France to challenge English supremacy on the continent, the Battle of Montiel (13 April 1369) would prove decisive. Pedro had been killed, the crown secured for Henry II. England and France were once more on the brink of war.

The return of master Walter dei Bardi to the Tower mint in February 1363 coincided with the growth of the Royal mint operation at Calais. Although the latter had limited production capacity since the siege of 1347, the growing demand from wool merchants to receive payment in English coin necessitated this expansion under new Mint master Henry de Brisele, to ensure that they no longer lost out in the exchange through local Flemish currency. Although a separate function from the Tower mint, Royal decree ensured that identical standards and metal fineness were upheld universally, with both similarly subject to the Trial of the Pyx on a quarterly basis. Evidently [although not exclusively employed] as a privy mark to distinguish between the two mint sites, a flag was applied to the stern castle on most larger Calais issues.

Post-Treaty Period [1369-1377]

With hostilities formally returning in May 1369, Charles V continued to provoke dissent amongst the Gascon nobility throughout the summer of 1369, finally 'confiscating' Aquitaine in November. The "Caroline Campaign" had begun. Edward III retaliated by restoring his claim to the French throne and titles as seen on his last issue of coinage. The French forces, having learned the all-too-costly lesson of open warfare against the English and their dreaded longbow, resorted to guerrilla warfare in battle, and a propaganda war to win over the hearts and minds of the local inhabitants of English-controlled territories. Limoges almost immediately surrendered to the French, only to be promptly besieged by the Black Prince's forces in September 1370. Although successfully recaptured, the contemporary historian Froissart suggests that Edward's subsequent punishment of the inhabitants went beyond the chivalric code, damaging the English cause at the time, even if the historical validity of the account is now seriously questioned. At Pontvallain [4 December 1370], one of the larger skirmishes of this period resulted in a French victory, undoubtedly precipitated by the collapse in military cohesion amongst the English ships commanded by Lord Pembroke, dealing a significant blow to naval supremacy and once again bringing into question the invincibility of the English force in open warfare. Whilst the Earl of Salisbury avenged this defeat the following season in an tip-and-trip raid on the Castillian merchant fleet at Saint-Malo, and with the King's son John of Gaunt staging a raid on French lands resulting in plunder but little else, the remainder of Edward III's reign was characterised by French dominance on the mainland including the symbolic loss of Poitou after the Battle of Chiset [21 March 1373].

RICHARD II [1377-1399]

The premature death of the Black Prince would ensure that his own son Richard would inherit the crown upon Edward III's death in June 1377, but not before Parliament had passed the first of several poll taxes to levy for the ongoing war effort. With this Royal inheritance came few remaining ancestral lands in France beyond the enclave and mint site of Calais, and territories around Bordeaux. French raiding parties would continue to harangue the English coast that summer, and a further defeat of Anglo-Gascon forces would occur at the Battle of Eymet [1 September 1377], where the English seneschal was captured. Differences between the English and French crowns would continue through 1378, with both sides supporting different Papal appointments. France reacted by confiscating Brittany, the English Parliament responded by levying a second poll tax to fund the Woodstock campaign of the summer of 1380. Despite France losing both her formidable constable du Guesclin and her king Charles V that year, it was domestic events in England that would dramatically shape the course of conflict for the remainder of the 14th Century. An attempt to levy a third poll tax in November 1380 met with significant resistance that boiled over into open revolt in May 1381. By June, a 'Peasant' army had raided the Tower of London and had forced a meeting with the King at Smithfield. International followers seized on the domestic turmoil, launching proxy raids through allies in Scotland. However, and in spite of internecine conflict raging amongst the military commanders, the English repulsed the Franco-Scottish army after it raided Carlisle in 1385, and followed this success with a further naval victory over the Franco-Castilian-Flemish wine fleet at Margate [24-25 March 1387]. In France, fortunes were rather different, with only a victory for England's ally King John I of Portugal over Castillian pretenders at Aljubarrota {14 August 1385} a comfort against defeats at Roosebeke {27 November 1382} and for Despenser's relief force at the siege of Ypres [June-August 1383]. Richard, an increasingly unpopular King, owing to his adoption of personal favourites and political battles with Parliament, would make a fateful decision in banishing his cousin Henry Bolingbroke in 1399 before proceeding on campaign in Ireland.

HENRY IV [1399-1413]

Following the cessation of the Caroline campaign in 1389, large scale hostilities between France and England ceased. However minor French raids along the English coast continued, the largest of which resulted in the battle of Blackpool Sands (April/May 1404), led by French commander William du Chastel. The battle unfolded in a causeway that despite best efforts did not result in the French gaining a foothold. Eventually they were forced into retreat, but du Chastel refused and was eventually killed in battle, with hundreds of others taken prisoner including three lords and twenty-two knights. A great shortage of bullion punctuated the reign, forcing the closure of Calais operations early into the new century and forcing Parliament to contemplate debasement to ensure the coinage remained sufficiently competitive as to lure bullion back to the mint sites rather than to the Flemish imitative workshops in the Low countries. In 1412, necessity forced this change, with the Noble being reduced from 120 grains to 108 grains.

"Secondary Phase Coinage":

The late Lord Stewartby furthered a contentious argument first proposed by Walters and Potter, namely, that the introduction of a mullet {'cinquefoil'} within Brooke's 'class B' coinage was a deliberate attempt to signify the onset of Henry V's reign, and thereby distinguish the subsequent issues made under Mint master Lewys John from the coinage of Henry IV (under comptroller Richard Garner) struck from 14 April 1413. As a consequence, he interpreted the class A and B coinage traditionally ascribed to the earliest issues of Henry V to actually be a 'Secondary Phase' of the light recoinage of Henry IV's reign. In his hypothesis, this would account for the otherwise indiscriminate application of a mullet {'cinquefoil'} across the pre-existing dies of his 'class P' $\{"H.IV - type V"\}$ to Brooke's "class A and B" $\{"H.V"\}$. The vendor is another proponent of this view, and thus has suggested this evidently transitional phase of coinage be distinguished from the later unchallenged issues of Henry V.

The addition of a quatrefoil 'stop' in the second quarter of the reverse is a standard feature throughout the Noble coinage of Henry V, and is visible across classes A (cf. BMC 1920.8.16.47) to C and beyond (cf. Schneider I, 214-15; 219-21, 225-36). It is however an highly unusual feature for the Half-Noble series, known only to this cataloguer from a similar example sold through this house in 2014 (cf. Spink 227, lot 533). That coin, from different dies, possessed lettering of Brooke's N2a form which Harris, in accordance with Brooke, has attributed to his 'B2' phase for silver coinage.

However Stewartby has previously stated: "No half-noble with class A features has been found, and class B is represented only by two obverse dies...the earlier of these dies, without extra marks, is paired with a class P reverse. The other, only known with a reverse of class C (undamaged N), has a broken annulet on the ship's side and a quatrefoil before HENRIC (see lot 68). He adds: "the period of production of dies with class A lettering must have been extremely short and their usage not much longer. Although they entered the general stock of dies [an A/B mule silver Halfgroat is known], the interchange with both adjacent classes, the direct mules between classes P and B (in gold as well as silver) that miss out class A, and the absence of any Groat or Halfgroat of class A with cinquefoil added, all indicate that the class A die-sinker made only a minimal contribution to the recoinage. The sudden arrival and disappearance of his elegant and unusual font...could suggest the work of an expert foreign engraver whose services and some of his tools were not available for long."

On the subject of the availability of tools, a further potential counter-argument has been made to class A attribution, in the form of a contemporary Henry V Farthing issue. Apparently struck with the portrait punch for a Noble, rather than the usual Half-Noble, this may indicate that punches for the latter were unavailable, as Stewartby opines, or indeed were not prepared at the time to be able to strike Farthings and by extension Half-Nobles. For the avoidance of doubt, the present cataloguer provides accompanying illustrations of the known class A 'N' forms {Brooke N1} from a range of denominations for prospective comparison.

HENRY V (1413-1422)

The death of Henry IV reignited interest in France, not least because his heir Henry V was of marriageable age. He immediately sought to open negotiations with the France to settle the outstanding ransom debt against Jean II, the restoration of his ancestral lands in Aquitaine, Normandy, Brittany and Flanders, as well as the marital hand of Princess Catherine, the younger daughter of King Charles VI. Charles offered a dowry but negotiations reached stalemate by early 1415. On 19 April, Henry gained permission from Parliament to sanction war. In August, Henry's fleet landed in the Seine estuary and within days would besiege the port of Harfleur {18 Aug.- 22 Sept.]. The following success would be a prelude to the wider reversal of English fortunes after decades of French control, as the armies once again drew battle lines, this time on St Crispin's Day {25 October}, near the small village of Azincourt. The English and Welsh army being predominantly made up of inexpensive longbowmen faced a French force perhaps as much as five times the size, and estimated by contemporaries to have had as many as ten French noblemen for every one English. Buoyed by past success, the French force made their now infamous cavalry charge, with the rest of this now famous English victory immortalised by Shakespeare. The result resonated through French nobility as had been the case after Poitiers, with the English force building on this success with further victory at the siege of Rouen {1418-1419}. Whilst a Castillian fleet once again bloodied the English nose at La Rochelle in 1419, the English ransacked the Scottish army treasury at Fresnay (early 1420), before being defeated at Baugé {22 March 1421}, where Thomas, Duke of Clarence was killed. To avenge his brother's death, Henry once again set out to France to relieve the Duke of Exeter in Paris, before successfully besieging Dreux, Vendôme, Beaugency and Villeneuve-le-Roy. He then concentrated his force on Meaux. Beginning his siege on 6 October 1421, early English losses included Agincourt-veteran John Clifford, and John Cornwall, son of 1st Baron Fanhope. However disease was to prove the bigger issue. As the siege dragged on over the winter and into the following spring, an estimated sixth of the English army was depleted by dysentery and small pox. Whilst positive news had arrived in the meantime from Windsor to state that the King had been delivered of a son and heir, Henry V had also caught sick, but refused to retire until he knew that Meaux had fall. His stubbornness was rewarded on 9 May 1422, but at great personal cost. Unable to ride, he sought refuge at Vincennes where he succumbed to his illness on 31 August 1422. Before his death, Henry had obtained an accord with the French king at Troyes, so that following Charles VI death his heir would also inherit the French throne.

HENRY VI, First Reign [1422-1461]

Following his father's premature death, Henry VI unexpectedly inherited the English throne at just nine months, and soon after also the French crown. His uncle Charles VII contested his claim to the French throne, reigniting the conflict at the battle of Cravant [31 July 1423], resulting in an early English victory. However French forces were conclusively avenged at La Brossinière [26 September 1423], where the English army was comprehensively routed. Pivotal battles resulting in important English victories then occurred at Verneuil [17 August 1424], described by some chroniclers as 'the second Agincourt'; before a small English detachment under Sir Thomas Rempston successfully repulsed a French force of 16,000 despite only mustering around 600 defenders at St. James-de-Beuvron [6 March 1426]. However the tide had once again turned, with the symbolic failure to capture Orléans [12 October 1428 – 8 May 1429], despite heading off a French relief force at Rouvray [12 February 1429], demonstrating an ultimately resurgent France under Joan of Arc. The victory at Rouvray or 'the Battle of the Herrings' as it came to be known after the supply carts were raided, was to be the last significant English victory of the Hundred Years War. Whilst Joan of Arc was subsequently captured at Compiègne by Burgundian forces and later executed, her martyrdom framed a succession of French victories that brought about the end of the Hundred Years War. Following French victories at Jargeau; Meung-sur-Loire; Beaugency; Patay [1429]; Gerberoy [1435]; Rouen [1449]; Formigny [1450], and finally Castillon [17 July 1453] which was the first European battle to see the use of cannon, the English land holdings in France began and ended at Calais.




