SIMON GREENWOOD FRPSL, 1955-2022


We mourn the loss of Simon in the philatelic world.

Simon was an eminent philatelist who was very modest about his collections and his knowledge.

He joined the Royal Philatelic Society London in 1990 and was elected to Fellowship in 2000.

Simon had fine collections of British East Africa and British Solomon Islands as well as very significant collections of British Guiana and British Honduras, in the West Indies area and was a regular attender at British West Indies Philatelic Study Group [formally British West Indies Study Circle (BWISC)] meetings. In October 2022 he was the keynote speaker at their conference at the Red Lion Hotel in Basingstoke and he showed a staggering display of British Guiana including a large number of 'cotton reels'.

A couple of philatelic anecdotes might illustrate what an unassuming man he was. He always volunteered to help with



mounting stamps at the National exhibition, Stampex where his stature was of great consequence in filling up the top row of the display frames. At the New York show in 2016 there was a BWISC meeting and though Simon gave one of the earlier papers he stayed all day to listen to everyone else's paper, reflecting his reserved and friendly approach to his fellow collectors.

His interests outside of philately included shooting, fishing, skiing, and Orienteering, at which he excelled. In recent years he did not exhibit stamps in competition but it was through the Study Circle that one got to know just how fine a collection he had, about which he was always very modest and self-effacing, but it was a truly remarkable collection, as can be seen from this catalogue and the forthcoming second part to be sold next year.

He would be excited that the gems of West Indies philately that he had the privilege of owning are now to be shared with other collectors worldwide.





1850-51 "COTTONREELS"

The stamps were typeset and printed in black on variously coloured papers at the office of the "Royal Gazette" in Georgetown.

The design was simple, consisting of a piece of printers' brass rule fashioned into a circle, within the circumference of which was the name of the colony in Roman capitals with the denomination in the centre of the circle. Three of the values -4 cents, 8 cents and 12 cents were issued on 1st July 1850, and the 2 cents was added eight months later. Before being sold to the public the stamps were usually validated by a postal official adding his initials. The names and initials of these officials were E.T.E.D(alton), H.A.K(illekelley), W.H.L.(orimer) and E.D.W(right).

The 2 cents was issued to prepay postage on a house-to-house delivery service in Georgetown, at the request of local merchants, which commenced on 1st March 1852, before then all mail had to be collected at the Post Office. However, this service was soon abandoned through lack of public support and thus lies the reason for the extreme rarity of 2 cents stamps. Only ten examples exist with three pairs known solely on covers.

The typesetting resulted in various philatelic types. W.A. Townsend identified four, three with thick frame, and one with a thin frame. Consideration of the 4 cents and 8 cents resulted in the observation that there were three thick frames to every one of thin. He omitted the 2 cents and 12 cents due to their rarity. However there are only two types, both thick frames, on the 2 cents value. Eight are type A, characterised by the first "I" of "BRITISH" leaning to the right, the other type (B) occurs only on the Miss Rose cover. Type B is characterised by a raised and left leaning first "A" of "GUIANA" and a minute break in the outer circle slightly to the left of the first "I" of "BRITISH".

Only the 2 cents and 12 cents are known in pairs, the first vertical where the measurements between the stamps varies from approximately 1mm. to 6mm., thus indicating that the stamps were printed in one horizontal row which was probably a pair. The 12c. were horizontally spaced approximately 14mm. apart. Vertical pairs are of the same type, horizontal pairs from a different type. The earliest dated examples (August to November 1850) are all type A, so possibly type A was printed from singles. Type A is of equal rarity to C but type B is twice as numerous.

Ten examples of the 2c black on rose are known, including four single stamps off cover and three pairs on cover. However, **only six examples, on cover or off cover, are available to collectors**, as the remaining four include one pair on cover in the Royal Philatelic Collection, and two single examples off cover - one in the British Library in London, and the other in the Post and Telecommunications Museum in Bonn, Germany. Of the three pairs recorded, the other two are not in the outstanding state of preservation of the pair on the "Weill Cover", as one is extensively repaired - in the Royal Philatelic collection, and the other, on the "Miss Rose" entire letter, is cut round and with parts of the frame line missing.

The finest known of the three pairs on cover, and therefore it can be stated that the "Weill Cover" is "sans parell" in terms of quality. With the exception of this pair, the other eight surviving examples are cut round, and as a result, this is unique. It exhibits the rarest value of the "Cotton Reels" and is, undoubtedly, together with the unique "Cotton Reel" combination franking, one of the two most important covers of British Guiana. One of the top three covers of the British Empire, as well as an extraordinary rarity of philately in general, which must be ranked as one of the top fifteen philatelic gems of the world. Note: The 2-cent was issued to cover the local letter rate for Georgetown's Penny Post, a service that proved to be unpopular and saw little use. As a result, no surviving examples of town post usages are known. It is believed that the stamps were printed using four tubes arranged in a straight line, producing a strip of four with each press operation.

This piece is known as the "Weill Cover", a name it acquired due to Raymond H. Weill, one of its previous owners. Raymond H. Weill was a renowned American stamp dealer and philatelic expert, widely considered one of the most influential figures in the stamp-collecting world. Along with his brother Roger Weill, he founded Raymond H. Weill Co., a prestigious stamp dealership based in New Orleans. The firm became famous for dealing in rare and high-value stamps or iconic philatelic gems, such as the British Guiana 1c Magenta and the Mauritius "Post Office" stamps. Their reputation was built on a combination of integrity, deep knowledge of philately, and exceptional service to clients. The prestigious "Weill" name associated with this cover reflects the importance of this philatelic gem.

The Stanley Gibbons catalogue values two cut round off-cover stamps at £650,000, while the cut square stamp, due to its great significance and rarity (only recorded on this cover), is unpriced -for rare stamps, Stanley Gibbons may estimate prices based on past trends, but in reality, actual sales could either exceed or fall short of these values-.

Note: This stamp was part of the de Coppet Philatelic Sale of 1893, a significant auction in philatelic history. The collection belonged to Frederick E. de Coppet, a prominent collector of rare stamps in the late 19th century. De Coppet was known for assembling one of the finest and most comprehensive collections of his time, particularly strong in classic stamps from various countries, including the British Empire, Europe, and the Americas.

The sale took place in New York in 1893, and it was organized by J. W. Scott & Co., then a famous stamp dealer and auction house. This auction gained attention due to the rarity and quality of the stamps offered, which included many highly sought-after issues from countries like Mauritius, British Guiana and early United States stamps. It is considered one of the early landmark sales in the world of philately, attracting prominent collectors and setting records for several items at the time.







This issue was produced in London on extremely delicate surfaced paper which rubs readily and, particularly in the case of the 4 cents stamp, we believe that perfect condition is unknown.

There are two types of each value and there are many distinctive feature, of which the following are prominent:

- lc. Type I: Pennant not at t op of the mast, no stop after "GUIANA". Type II: Pennant at the top of the mast, stop after "GUIANA".
- 4c. Type I: The "C" of "CENT" is circular, the upright of the "T" is central; the foresail has two ratlines Type II: The "C" of "CENT" is oval, the upright of the "T" is to the right; the

foresail has three ratlines.

The impressions were laid down on the stone in horizontal pairs, each pane of twenty being in horizontal rows of four.

In the case of the 1 cent it is possible to allocate the number on the row. First stamp; Type Ia, a dot outside the right frame at top. Second stamp; Type IIa, a guide line extension of the bottom frame line at right. 

This issue, like the "Cottonreels", was printed on poor quality paper, coloured magenta, rosecarmine and blue. Due to the delicate nature of the paper, these stamps suffer from rubbing and thinning. The stock of current one cent, two cents and four cents had become useless as they had stuck together and Richard and Colebeck were ordered to print provisional stamps at the Royal Gazette Office were ordered to print provisional stamps at the Royal Gazette Office.

The one cent and two cents were printed from the same type with the value altered. The sheet was four horizontal rows of six. Three different types of border were used. The top two rows had a border of split ovals (sometimes called "beetles") set diagonally (A): the third row and the first row and the first two stamps of the fourth row had a border of pearls (B) and the last four stamps had a border made of small ornaments resembling a stalk with four berries (C). The stamps were rouletted 6 but are imperforate at the sheet edge.


Before issue, each stamp was initialled in the centre "*R.M. Ac. R.G.*" by R. Mather, the Acting Receiver General and Commissioner of Stamps. The initials were in black on the one cent and red on the two cents.

Remainders without initials were found in 1881 and bought by Mr. Justice Philbrick.

Four Cents Black on Blue

The setting differs from the two lower values and there are three different borders. The top row and the first four stamps on the second row had a border of small fan-shaped ornaments known as "hearts and pearls" (A). The last two stamps in second row and the fourth row had a border of crossed roseaces (B) and all but the 11th and 12th stamps (B1) were without the four inner frame lines which were also found in all type A. The third row had an ornamental trefoil pattern and no inner frame lines (C).

The signatures on this value were written in an alkaline ink which discharged the blue from the paper, the writing appearing in white.

Notes on the reverse of this letter read: "This is submitted with reference to Mr. Gallagher's minute of yesterday. GM 4th January 1882" and "This course must be adopted there is no help for it, but initialling will be no security. A real security will be found, I think, in perforating each stamp "SPECIMEN" in Govt. Secty. Office. It can be lent to the Rec. General and used under proper conditions. W.Y. (WAG Young, Lieutenant Governor) 4.1.82"
