NOTICE TO BIDDERS

Dear Bidder,

We welcome you to our auction house. Please note the points below to assist you with the registration, bidding and payment at our auctions.

REGISTRATION FOR BIDDING:

If you are registering with us for the first time or have not bid successfully in the past, we require a deposit of HK\$50,000. If you intend to bid more than HK\$200,000 the deposit may be higher. The deposit will be deducted from your invoice should your bid be successful. If you are unsuccessful, your deposit will be returned by the same means by which it was paid. In addition we will ask for your bank and trade references.

We encourage new clients to register for bidding at least 48 hours prior to the commencement of the sale to allow sufficient time to process the registration.

Prior to the auction, some lots may be designated as "Premium Lots", which means a deposit may be required before placing a bid on the item for sale. Information will be posted on our website in such an event.

Spink have the right at our own discretion to refuse admission to our premises, attendance at an auction and decline submitted bids.

BIDDING METHODS:

In person

You will be given a registration form that you will need to fill in providing your up to date address and contact details. Please always have your photo ID with you and, if you are bidding on behalf of a company, your business registration. ID information is collected for registration purposes only and will be kept confidential.

Submitting a bid form by email/post/fax

Again please always provide your full up-to-date contact details together with the lot numbers and the amounts up to which you would like us to bid on your behalf exclusive of Buyer's Premium/tax/postage. Should you not receive our email confirmation of your bids having been received please call our office to make sure they have been received and processed.

Submitting bids via our website

To submit bids via our website www.spink.com you need to be registered and logged in. You can leave bids via this method up to 3 hours before the commencement of the sale.

Bidding live on Spink Live

You must be registered and logged into either our website <u>www.spink.com</u> or the Spink Live App that can be downloaded from App Store. On our website access the sale via Spink Live button on the home page or through Auctions – Auction Calendar page. In the Spink Live App select the sale from the list. The live bidding platforms are available from one week prior to the sale and made active for live bidding shortly before the commencement of the sale. Please check that you are approved for bidding. During the live feed you will be able to see and hear the auctioneer.

Telephone bidding

If your bid is successful the Purchase Price will be the sum of the final bid and Buyer's Premium as a percentage of final bid, a shipping charge if applicable and a fee for paying by card. Buyer's Premium rate is 20% of the hammer price.

EXTENSIONS (STAMPS ONLY):

Prospective buyers, who wish to obtain an expert opinion on any lot other than a mixed lot or lot containing un-described stamps, are requested to notify Spink in writing no less than 48 hours before the commencement of the sale. PAYMENT METHODS:

HOW TO BID WITH THE SPINK LIVE APP?

Please Note: In order to participate in any of our auctions you need to log in and register for the auction in which you will be placing bids. For registration, please refer to the *Instructions for downloading SPINK LIVE APP*.

TIMED AUCTIONS:

Timed auctions allow a single lot to be up for sale for a fixed time. The amount of time left is displayed by the timer which counts down till the end of the auction. The first lot in each timed auction on 1th and 11th January 2021 will end on 14:00:00 and each subsequent lot is timed to end at 30 second intervals if there are no last minute bidders. However please note the following:

1. During the auction, the bid price gets updated in real time so you will know right away when you get outbid by another buyer.

2. If there is more than 1 bidder bidding on the same lot at the same time, the time will automatically extended. If there are multiple time extensions the following lot may end before current lot.

A STUNNING EARLY SAIGON NOTE DATED 1893. THE KOLSKY-MUSZYNSKI PLATE NOTE!

French Cochin China, 5 Piastres Law of 1875, manuscript dated 19th July 1893 at Saigon, Banque de l'Indochine 5 Dollars = 5 Piastres 19.7.1893 PMG graded VF 35. The Kolsky-Muszynski Plate Note. A stunning note in superb condition, essentially new but folded three times. A couple of closed pinholes at upper left. The first note of the newly founded (1875) bank, and one of only two \$5 notes on the founding Law of 1875 known to have survived. The other is graded Good and was described to the owner twenty years ago as "heavily rusted" — it still sold then for roughly USD10,000. This note is a prize for the entire French Colonial series. It should be noted that the inscription on the back reflects the colonial status of French Cochin China at the time, as later issues of notes were made, the back printing was changed to reflect the growing territory under French control and under the mandate of the bank. A unique opportunity.

Late in World War II, as it became clear that it would be a matter of time before Allied forces would prevail over those of Imperial Japan, currencies were prepared for release on the liberation of several countries and territories.

In these territories Japanese "banana currency" was circulating, and had depreciated greatly in value in comparison to the hard currency notes that it replaced.

The moment each territory or colony was liberated, commencing in August of 1945, good money would be required to maintain confidence in the Allied occupation. This essentially had to be printed, packaged, shipped and stored at the nearest practical point to each, so that issue could take place virtually in tandem with Allied liberators taking the Japanese surrender.

Thus we see notes prepared in advance for Malaya, Indochina, Netherlands Indies, Sarawak, and the Philippines.

While it was until now not generally known, preparations were undertaken for the ultimate liberation of Sarawak -- Rajah Vyner Brooke's state having being captured by the Imperial Japanese forces in early 1942.

The \$5 note illustrated here represents a "survivor" of the issue planned for liberation and printed in Britain on the instructions of the Sarawak government.

Most interestingly, the pre-war banknotes of Sarawak had long been guaranteed by the government's deposits in London, and thus were entirely redeemable there at full face value.

Banknotes issued in British North Borneo by the Borneo Company were issued on a different basis: they were not backed by bonds or other investments in London, and this presented a problem to the Allies.

Thus the question arose of how to redeem pre-war notes in British Borneo after August 1945.

The immediate issue in Sarawak was British military currency, with it is understood Sarawak notes that had been hidden or stored through the war in the Treasury being accepted.

However, given the uncertain future of Sarawak, these notes also faced an uncertain future!

The damage caused by the wartime Japanese occupation and military hostilities ultimately lead Rajah Vyner Brooke to the difficult decision that he could not afford to rebuild his territory and, slightly less than a year after liberation, on 1 July 1946 he surrendered Sarawak to the British crown.

Sarawak then became a crown colony.

The question of what to do with the 1944-45 notes remained in play until Sarawak ultimately decided to join the Malayan currency union.

This lead to the new issue of notes for British South East Asia under the aegis of the Board of Commissioners of Currency of Malaya & British Borneo. The new Board formally came into existence on 1st January 1952. With its inauguration all discussion regarding Sarawak and its proposed or planned note issue permanently terminated.

Fortunately original records have now been uncovered by the author relating to the deliberations behind the issue of these notes.

Most interestingly as the notes were not dated and little was known of them a manuscript inscription on the back giving only the date "1949" lended evidence to the intention at least at this late date to place them into circulation in Sarawak.

Interestingly this old photograph brought several thousand Pounds!

However, it is with the discovery of original records that the story of Sarawak's last notes will be told, and the purchaser of this note will be entitled to a complete set of in excess of 100 documents.

Pedigree: This note, together with a 5 Dollar and 10 Dollar of the same series and another 1, 5, and 10 of a second series, appeared in the collection of the great Malaysian numismatist, Dr. Chan Chin Cheung. They are illustrated in the memorial volume of the Chan collection, entitled "Paper Currencies of the Straits Settlements, Malaya, British North Borneo, Sarawak, and Brunei: The Collection of Dr. Chan Chin Cheung", published in 1991.

The breakup of the Chan Collection

The notes were subsequently acquired by William Barrett and have remained in his collection to this day. At the time of acquisition, however, he could only speculate at the purpose of the printing of these complete banknotes.

At about the same time, William Barrett was shown by Lucas Chin, Director at Sarawak's national museum, Muzium Sarawak, one note -- or at least one note -- in a glazed frame caked in dust, what he recalls being one original note or a reproduction thereof.

Whether this item is still at Muzium Sarawak is not presently known.

*A unique opportunity to acquire a note of the region printed during the Japanese occupation for circulation on liberation, held back during the next uncertain year, leading up to Sarawak's cession by Vyner Brooke to the British crown, and then intended to be circulated in the new crown colony during the late 1940's and into the early 1950's.

Regretfully the printer, Bradbury Wilkinson & Company, lost or disposed of many of its records, and there is apparently absolutely no reference to the printing of these magnificent notes in their surviving archives.

Brooke had minted no coins nor had he any notes printed that might be circulated once the Japanese had been expelled. When Britain became aware of Brooke's intent to cede, they ensured a supply of emergency currency would be available for their new colony in the same manner they were doing for Malaya. It is not known whether the Sarawak emergency issues were prepared by Britain in conjunction with Brooke or not. Whatever that detail the result is the three small change 1945 notes now on offer. Essentially, these are specimen proofs if not trials. There is no evidence these notes were printed in any quantity. None were ever issued. The design of each of the 1945 notes is similar in some respects to Sarawakís pre-1942 issues. Each names the issuer as THE GOVERNMENT OF SARAWAK as do those pre-1942 issues but the 1945 notes lack any provision to be signed by TREASURER OF SARAWAK. Rather, the matter is left open with a space labeled FOR THE GOVERNMENT OF SARAWAK. And all the 1945 notes lack the vignette of Charles Vyner Brooke present on all his earlier issues, including an emergency 10 cents produced in 1940 (P-25).' (Pick not listed), PMG 66EPO, 65EPQ and 66EPQ respectively. Virtually the only way to acquire a set of this design. A fully printed set will be offered in Spink's NYINC sale on 15th January 2021. THE ANDAMAN ISLANDS

The Andaman Islands lie in the Bay of Bengal, 120 miles from Cape Negrais in Burma, 780 miles from Calcutta, and 740 miles from Madras. Five large islands closely grouped together are called the Great Andamans, and to the south is the island of Little Andamans. There are some 204 islets, the two principal groups being the Ritchie Archipelago and the Labyrinth Islands.

From the year 1858 until March 1942, when Japanese forces occupied the Andaman Islands, they were used by the Government of India as a penal settlement for life and long-term convicts. The penal settlement was abolished on re-occupation in October 1945. The Andaman Islands are now administered by the President of the Republic of India acting through a Chief Commissioner and an Advisory Council. The seat of administration is at Port Blair.

The position of the Penal Settlement at Port Blair when founded in 1858 was one of great isolation, and the difficulty and uncertainty of communications with the outside world were extreme.

In September, 1860, Capt. J. C. Haughton, Superintendent of the Settlement, had to face a temporarily depleted treasury with many calls upon it for cash to meet current needs. To meet this need, the Superintendent prepared sealed and signed cardboard tickets which passed current for One Rupee. A further and more elaborate issue was made in the following month.

From this initial issue of a token currency, the use of tokens in the place of cash was deemed to be a great advantage in a Settlement consisting almost entirely of convicts. The Superintendent therefore, recommended to Calcutta the permanent continuance of a token currency, in the place of cash, for the Andamans. His suggestion was for an issue of 20,000 copper tokens, to be struck at the Calcutta Mint, "with any simple inscription such as, *Andaman One Rupee Token*, with the year on the reverse and a hole in the middle". As an alternative to a new die, Capt. Haughton suggested the use "of the die of the double gold mohur or any coin or medal not in general use".

The Government of India approved this request and the tokens were struck at the Calcutta Mint. The mint-master, Col. Baird-Smith, utilised the design of the Straits Settlements Cent coin of 1845 for the obverse. Following the general changes in the coins of India in 1862, a further issue of tokens for the Andamans was made in 1866 when the obverse design was changed to the crowned bust type of the Indian coins.

During a period when the Penal Settlement was placed under the orders of the Chief Commissioner of British Burma, an Inspecting Officer reported adversely on the token system as a disciplinary measure and the copper tokens were recalled in 1870.

The reverse design was suggested by Capt. J. C. Haughton, Superinten-dent of the Penal Settlement, Andaman Islands, and was prepared at the Calcutta mint, Bengal. The tokens were recalled from circulation by the orders of the Government of Inda. The Circular Notice notifying their recall was signed by Col. H. Man, Superintendent, on the 26th March. 1870. They ceased to circulate on the 28th April of that year. At that date, 17,788 had not been returned to the Treasury at Port Blair.

The majority of the tokens available the collectors appear to be proof or uncirculated specimens. This being so, proofs are not separately noted unless the metal differs from the normal copper issue.

The chinese characters expressing the value of the tokens below the dollar denomination are not those commonly used on European issues. On the 50 cents tokens, the value is indicated by the numerals Wu Shih = fifty. For the 20 and 10 cents, the main character is an abbreviation. Three forms occur on the 20 cents tokens and are variously stated to be abbreviations of Fên or Ch'ien. The Fén being the tenth part of the Ch'ien or mace, while the Ch'ien or mace is the tenth part of the Tael. Although not in accordance with normal usage the intention of the abbreviated character in either form was seemingly to express a tenth part. Thus Êrh Fên is here read as "two tenths" of a dollar i.e. 20 cents.

The Sapeque Paris Mint was the denomination most in demand and formed almost the entirety of the Cochin China circulation. Thus I believe that this denomination would have been prepared first. This would suggest that this is the earliest identifiable step in the preparation for the entire coinage for Cochin China.*

Major Fred Pridmore in The Coins of the British Commonwealth Nations, Part 4: India, volume 2: Uniform Coinage makes reference to the then know official proof sets made for British India each was prepared on the instruction of a new coinage. Of these only the 1949 and one 1947 set has been reported in collectors' hands. These are listed on page 199 and comprise the following:

1) 1911 Rupee, ¹/₂ rupee, ¹/₄ rupee, 2 annas silver, "Four coins in plush lined case, stamped 'His Majesty's Calcutta Mint".

This latter listed in the B A Seaby Coin & Medal Bulletin, 1969, p.182.

In addition to these five presentation sets Pridmore lists on page 193 through 198 various India single proof coins, either in the correct metal or otherwise.

However, it can now be seen that an earlier and previously unrecorded set officially struck for a particular reason and unknown to Pridmore has survived and has been in the present collection for some forty years.

In 1904 the Colonial and Foreign Office in London gave instructions that examples of all current colonial coinage be supplied to it. The Indian mints took the instruction to heart, and not only struck proof examples of the coins currently being coined, but in addition prepared dies for denominations still legally in circulation though not at the time being produced.

As a result the copper ½ Anna of 1904, Pr 595, came into existence. This large coin had not been struck for circulation since 1877, though proofs had been made in 1879, 1884, 1890, 1891 and 1893. As no Edward VII coinage ½ Anna had been contemplated, though the coins

was still legally current, dies were prepared to show in effect how the coin would look were it being currently struck.

A second piece with a similar background is the Ceylon 5 cents of 1904. The last of the large-size bronze 5 cents had been struck for circulation in 1892, and subsequently a reduced size nickel 5 cents was to be issued years later in 1909. Notwithstanding in 1904 the Indian Mint authorities prepared dies and once again in effect created a coinage that did not actually exist.

An example of the Ceylon 5 cents of 1904 appeared in the sale of the noted collector Jerome "Jerry" Remick, sold at Spink in 2006, where as Lot 231 it brought GBP12,348 (then approximately US\$23,090).

While in 1911 and later official VIP presentation proof sets recorded by Pridmore as struck in Indai contained only a single coin or a set of current coins, the undoubted reason for the inclusion of Victorian coins in this discovery set is that in 1904 Victorian coins were still legally current and in circulation in India. In fact in 1904 virtually all the coinage in circulation in India would have been Victorian. Accordingly the Master of the Mint arranged for strikings to be made from (repolished) Victorian dies as well as from the current specially prepared Edward VII dies.

1904 was to see regular coinages by both Calcutta and Bombay. However, no coinage of $\frac{1}{2}$ Rupee by either mint, nor $\frac{1}{4}$ Rupees of the Calcutta Mint, nor 2 Annas of Calcutta were to be struck in 1904.

Interestingly, on the Indian Government Mint Bombay price list of specimen coins available for restriking the $\frac{1}{2}$ Rupee of 1904 is listed as being available. Quite possibly these were to be struck from dies that came into existence to create the $\frac{1}{2}$ Rupee denomination of 1904 for inclusion in the present set.

The short reign of Edward VII was marked by a number of design and metal changes, as seen in the large number of patterns proposed during his reign. Accordingly, it may have been due to the series of patterns and trial commencing in 1903 and reaching a peak in 1904-1905 that the Colonial Office requested a set of the 'current' pieces with which to make comparisons to any new proposals.

Rather than repeat the information published then -- and essentially there is no new information that has come to the attention of the collector -- the original page is illustrated here. For those of you unfamiliar with the book, the dust jacket is also illustrated. One example appeared in the collection of noted English collector of the mid-twentieth century, Lady Deveen, and was illustrated in her auction held at Glendining in 1964.

When exactly these pieces were made and by who is still not known. The example offered here is 15.2 centimeters in diameter and weighs 74.7 grams. It is struck in .750 gold, and would be rated at Extremely Fine in condition.

With the Dutch equivalent selling in the range of USD250,000 (see the recent Heritage sale), this piece is a show-stopper at a fraction of the price.

A third unusual gold piece in the authors collection is in appearance similar to the Banjarmasin doit and the large gold pieces illustrated above. This is a gold coin made in the style of the Spanish-American gold & escudos issued during the rule of Charles III (from 1772 to 1788) in Mexico and the South American colonies. In particular the use of pellets for the chain around the shield is reminiscent of those that appear on many of the doit imitations. However, as this coin has no provenance, and as there is no supporting documentary evidence, it is only illustrated here as being possibly of southern Borneo origin.



Gold "8 excudes" made in imitation of a Spanish-American gold 8 excudes of Charles III (1760-1788). This coin bears a copy of the portrait of Charles, together with garbled inscriptions and the date "1772". The reverse or thickle side is somewhat less faithful to the original, but the basic designs are clear, including the value "85" for "right scudos". PENANG

History:-

Penang, or Pulau Pinang, is an island situated near the west coast of the Malay Peninsula at the northern end of the Straits of Malacca. It was ceded to the East India Company in 1786 by the Rajah of Kedah, and constituted the first British Settlement in the Malay Peninsula.

In 1805, the settlement was raised to the status of a separate Indian Presidency but it was reduced again to a Lieutenant Governorship subordinate to Bengal in 1830.

In 1826, Penang, Malacca and Singapore were incorporated under a single government, which, from 1867 was a crown colony known as the Straits Settlements.

Currency:-

The standard coin adopted at the date of founding in 1786 was the Spanish Dollar, and the local coinages specially struck for Penang from 1786 until 1810 were for fractional parts of the dollar. In 1826 the Sicca rupee of the Bengal Presidency was established as the money of account, and the local coins then in circulation, and subsequently issued dated 1825 and 1828, were revalued as fractions of a rupee.

Despite the short period of time, the coinages issued specially by the E.I.C. for Penang consisted of one in silver for three denominations, five in copper, and a local coinage struck in tin making seven coinages in all.

The first coinage struck for the Island was a Pice or Cent of copper. It was executed at the Calcutta mint and apparently accompanied the founding expedition. The design was limited to the "Balemark" of the E.I.C., and the coin bears no date or island name. The reverse side is blank. In 1787 a silver and copper coinage was instituted by the Company. None of the denominations bear any indication of value, but they were fractions of the Spanish dollar. The silver coins are dated 1788, while the copper issues are dated 1787. Both coinages were struck at the Calcutta mint, Bengal.

Following the change in the status of the settlement in 1805, and a general shortage of small change in the bazaar, the Governor introduced a Pice or Cent coinage struck in tin. This coinage was manufactured locally on the island, and was so extensively counterfeited that in 1809 a request was made for the island to be supplied with a sound copper coinage. The Court of Directors, London, approved this request, and a copper coinage consisting of a Pice or Cent, and $\frac{1}{2}$ Pice or $\frac{1}{2}$ Cent was preprared at the Royal Mint, London. Upon its receipt in Penang in 1812, the local tin Pice or Cents were called in and demonetized.

Two further copper coinages were requested in 1825 and 1828. Both were approved, and the two coinages were struck in the Madras Mint, the design being copied from a specimen of the Royal Mint striking of 1810.

In 1826 the money of account of Penang was changed from the dollar to the Bengal Sicca Rupee. This was a policy forced upon the Penang Government by the Court of Directors of the E.I.C., who were at the time attempting to unify the currency of British India, including the other possessions of the Company. With this change of system, the special copper coinages of Penang changed from

Pice or Cents	100 to the Spanish Dollar to
Pice	48 to the Bengal Sicca Rupee.

The series of coins specially minted for Penang closes with a copper issue of 1828 and from then onwards the settlements of Penang, Malacca and Singapore were treated as one unit, although their respective requirements varied considerably.

The fineness and weight standard is based upon a Spanish dollar of 417.60 grains and fineness 902.7. Usually the coins fall slightly below this official weight.

The Balemark of the East India Company is a heart-shaped shield divided into four compartments containing the letters V[nited] E[ast] I[ndia] C[ompany]. Above; a large 4. This particular form which appears on the coins was devised after the merger of the old and new Companies in 1708.

The reverse inscription is a barbarous attempt to render the Island name in Arabic script according to its phonetic sound in English. All the coins struck for Penang are curious in that in no case is a value stated.

Two die varieties have been noted of the half dollar.

History:-

Sarawak is a state in north west Borneo and originally a part of the Sultanate of Brunei.

The government of a part of the present territory was obtained on the 24th September, 1841, by Sir James Brooke from the Sultan of Brunei. From time to time additional territory was added and in 1888 the state was accorded British Protection. On the 1st July 1946, Sarawak was ceded to the British Crown.

Currency:-

From the date James Brooke became the Rajah of Sarawak, the currency has been based on the dollar standard of Singapore, and since the year 1863, Sarawak currency history has followed, in principle, that of the Crown Colony of the Straits Settlements.

The first coinage issued by Brooke was provided for in 1842, and consisted of a copper keping denomination. This coinage in its weight, size and general appearance was similar to the copper tokens then imported for general trade by the merchants of Singapore.

Following the development of the country a new copper coinage was introduced in 1863. This consisted of a Cent, helf Cent and quarter Cent, and was identical in size, weight and value to the similar denominations of the Straits Settlements.

For some years prior to 1890, the Sarawak copper cents in common with those of the British North Borneo Company and the State of Brunei, had been imported into Singapore. About this time, legislative action was taken in Singapore to prevent the circulation of such foreign coins. To assist the Straits authorities in this matter, the Rajah of Sarawak published a regulation in 1891 forbidding the export of his coin, and the following year (1892) he changed the design of the Sarawak cent, from a whole disc to a centrally pierced piece.

Further additions to the Sarawak denominations took place in 1900 when a silver coinage, consisting of fifty, twenty, ten and five cents, was introduced. The weight, fineness, size and denomination of this coinage corresponded to the similar silver subsidiary coins then in use by the Crown Colonies of Hong Kong and the Straits Settlements. In January 1906, the standard unit — the dollar — was restricted to the Straits Settlements dollar, and all other forms of dollars were no longer accepted as current.

In 1920, a nickel coinage was authorized consisting of ten, five and one cent values. This change to a nickel composition was due to the fantastic heights to which silver had reached following World War I (1914-1918).

From 1920, the currency of Sarawak followed closely the pattern of the Straits Settlements. In 1925, the Straits Settlements decided to restore the standard of their subsidiary silver, and the first coins of the restored standard were made in 1926. Accordingly, in 1927, Sarawak made a further issue of silver coins to the 50 and 20 cents denomination. Nickel 10 and 5 cents were also struck of the previously established design. A new copper cent was also minted and reverted back to a whole disc, for

during the intervening period since the last copper cent had been struck (1897), the Straits Settlements had ceased to issue a round copper cent. Its place had been taken by a bronze coin, square in shape, in 1919.

The depression period of the 1930's and the need for still smaller values saw the re-introduction of a copper half cent of a new form. Again, Sarawak followed the currency policy of the Straits Settlements who had re-introduced this denomination in 1932.

Further small issues of nickel 10 cents and copper 1 cent were made at intervals until 1942, when the occupation by the Japanese of British controlled or protected areas saw, in effect, the end of the independent State of Sarawak.

SINGAPORE

History: ---

Singapore was founded by Sir Stamford Raffles in February 1819, and was administered from Fort Marlborough, Bencoolen, Sumatra, until June 1823. Thereafter Singapore was a dependency of Bengal until 1826, when it was amalgamated with Malacca and Penang to constitute the Presidency of the Straits (or Eastern) Settlements.

Coinage and Currency:-

Singapore, like Penang, was virtually uninhabited when the E.I.C. obtained possession. From the very first the Spanish dollar was the nominal coin of account of the new settlement, but owing to the varied trade, a great variety of other coins came into circulation.

It was not long after Singapore had been established that the deficiency in the general currency medium attracted the attention of the administration. In 1823, the Spanish dollar was declared the standard of value, and other coins were regulated to conform to this standard. At the same time, a special currency of small values, being divisions of the dollar, was requested from India for use, not only in the settlement of Singapore, but in Penang, Bencoolen and surrounding native states.

Silver:-

- (a) Dutch Florin or Guilder. (The Guilder was commonly called a Rupse by the natives)
- (b) Every description of rupee current in British India.
- (c) Dutch silver pieces of 2, 6 and 9 stivers.

Copper:--

- (d) Dutch Doits. (several types)
- (e) Penang Copper Pice or Cent coinages.
- (f) Bencoolen Pice (keping denominations dated between 1783-1804).

(g) Brass cash of China.

The most common of these various coins were the European Dutch silver 2 Stiver and the copper Doit. It was these two denominations that the Singapore Resident suggested should be used as models for a small currency; one in silver the 1/30 th of a dollar, and one in copper the 1/3rd of a cent, to be issued by the E.I.C. for its eastern settlements, and for general trade with the neighbouring native states.

Pattern 1/3 Cent:-

In 1824, the Calcutta mint prepared dies for a pattern 1/3rd cent, and struck silver and copper specimens for examination by the mint committee. Due to certain objections and difficulties raised against such a coinage by the Calcutta mint master, no further action was taken in Bengal, and the coinage failed to mature.

After the unification of the settlements in the Malay peninsula in 1826, the currency and coinage covered a far wider field.

Currency:-

The Spanish dollar divided into 100 cents.

Denomination:-

NONE : but a pattern coin was struck for 1/3rd of a CENT.

SUMATRA

History:-

In 1684 the East India Company was expelled from Bantam on the Island of Java, and the establishments went to the Malabar coast. Three years later a settlement was made at Bencoolen on the west coast of the Island of Sumatra. A fortification called York Fort was built. In 1714, the settlement was moved three miles further south, and a fort was erected which was named Fort Marlborough.

This was the principal settlement of the East India Company in the East Indies from 1714 until Penang was founded in 1786. It was also a convict settlement where the Indian criminals were sent to labour on the Company's plantations.

In 1824, the English settlements and interests in the Island of Sumatra were exchanged with the Dutch for their settlements in India and Malacca.

Coins and Currency:-

By the time the European Trading Companies arrived in the Malayan Archipelago, the principal coin used in trade was the Spanish silver dollar. Local rulers of several states, particularly in Sumatra, had also founded local currencies and struck their own coins in gold and tin. These local coinages were of little use to the European merchants, and they used the Spanish dollar or other coinages associated with their trade connections, e.g. Dutch (European and locally minted issues), English East India Company coins of the several Presidencies of British India, and other foreign coins with known and accepted trade values.

The first coins struck by the E.I.C. for Sumatra were issued in 1783. They were based upon a Spanish silver dollar divided into 400 parts or kepings. The initial issue consisted of silver half dollars or two suku pieces, and copper two kepings or half cents. Later issues were confined to copper coins denominated in kepings. An interesting emergency issue consisted of a token half dollar in copper overstruck on earlier 3 keping pieces. This is stated to have been issued by Governor Bruff in 1797, and is possibly connected with payments to troops during a period of temporary shortage of cash supplies, or used in payment to the convicts.

Another point of considerable interest is that from the year 1786, all the E.I.C. coinages for Sumatra were struck by Matthew Boulton at Soho, Birmingham. In fact the first coinage contract for actual currency coins struck by Boulton was the Sumatra copper issue of 1786, and consisted of an order for 100 tons of three denominations.

Patterns and Proofs:-

In view of the short period of time that special coinages were provided by the E.I.C. for their Sumatra settlement, some remarks are necessary in regard to the large and varied number of proof and pattern pieces that are recorded for this settlement.

At the latter end of the 18th century, the minor currency of England was in a deplorable state. In the case of the copper coins they were mostly counterfeits. This attracted the attention of the great Birmingham industrialist, Matthew Boulton, who set out to reform the process of coinage and defeat the counterfeiter. After some years of experiment he applied the power of steam to coining presses, and completely revolutionized the art of coining.

Boulton took a great pride in the products of his new mint. One method he adopted to advertise their excellence was to distribute proofs and patterns of coinages already undertaken. A number of these specially struck pieces were also given as gifts to his many interested friends and companions in the arts.

SUMATRA

In view of Boulton's rather free distribution of proof and pattern coins in the early days of the new mint at Soho, it is not possible to state with certainty what patterns of the Sumatra series are genuine patterns. Some, like the oval 2 keping pieces appear to have been specially struck for the purpose of advertisement, or as gifts to friends, and were not prepared as genuine patterns for an actual coinage.

The design of the Sumatra copper coins had been established in 1783, before Boulton struck the 1786 dated series, and on the currency coins the 1783 design was faithfully followed until redesigned in 1804. It is quite probable that all the "Patterns" now listed belong to the category of "advertisement" and were produced according to Boulton's whim or fancy.

Currency:-

The Spanish silver dollar divided in Sukus (an imaginary quarter dollar) and kepings or Kepengs.

The Spanish dollar was valued at 5/- sterling.

The keping (copper) equalled 400 to the dollar.

Denominations:-

Silver 2 Sukus or Half dollar. Copper Half Dollar (token) 4 kepings 3 kepings 2 kepings 1 keping

3.4.1 If you wish to obtain an expert opinion or Certificate of Authenticity on any Lot (other than a mixed lot or lot containing undescribed stamps) you must notify us in writing not less than forty-eight hours before the time fixed for the commencement of the first session of the auction. If accepted by us, such request shall have the same effect as notice of an intention to question the genuineness or description of the Lot for the purposes of clause 5.9 of these Terms and Conditions and the provisions of clause 5.9 shall apply accordingly.

3.4.2 Notice of a request for an expert opinion or Certificate of Authenticity must give the reason why such opinion is required and specify the identity of your proposed expert which will be subject to agreement by us. We reserve the right, at our discretion, to refuse a request for an expert opinion or Certificate of Authenticity including (without limitation) where the proposed expert is not known to us.

3.4.3 If we accept a request for an expert opinion or Certificate of Authenticity we will submit the Lot to the Expert Committee. You acknowledge and accept that the length of time taken by an Expert Committee to reach an opinion will vary depending on the circumstances and in any event is beyond our control.

3.4.4 We will not accept a request for an extension on account of condition. Any Lot described in the catalogue as having faults or defects may not be returned even if an expert opinion or Certificate of Authenticity cites other faults or defects not included in the catalogue description, other than in the case of a Forgery.

3.4.5 Should Spink China Limited accept a request for an extension under the foregoing provisions of this paragraph, the fact may be stated by the Auctioneer from the rostrum prior to the sale of the Lot.

3.4.6 It should be noted that any stamp accompanied by a Certificate of Authenticity is sold on the basis of that Certificate only and not on the basis of any other description or warranty as to authenticity. No request for an extension will be accepted on such a stamp and the return of such a stamp will not be accepted.

3.4.7 If you receive any correspondence from the Expert Committee in relation to the Lot, including but not limited to a Certificate of Authenticity, you must provide us with copies of such correspondence no later than 7 days after you receive such correspondence.

4 AT THE SALE

4.1 Refusal of admission

Our sales usually take place on our own premises or premises over which we have control for the sale, and we have the right, exercisable at our complete discretion, to refuse admission to the premises or attendance at an auction.

4.2 Registration before bidding

All bidders must be registered either by completing a registration form or creating an account online. Please be aware that we usually require buyers to present identification before making a bid at auction, undergo a credit check or provide a trade reference. If you have not bid successfully with Spink in the past, or you are registering with us for the first time, we reserve the right to require a deposit of up to 50% of the amount you

intend to spend. Such deposit will be deducted from your invoice should you be successful. If you are unsuccessful at auction, your deposit will be returned by the same means it was paid to Spink.

Some lots may be designated, prior to the auction, as "Premium lots", which means a deposit may be required before placing a bid on the item for sale. Information will be posted on our website in such an event.

4.3 Bidding as Principal

When making a bid (whether such bids are made in person or by way of telephone bids operated by Spink, commission or online or email bids), you will be deemed to be acting as principal and will be accepting personal liability, unless it has been agreed in writing, at the time of registration, that you are acting as agent on behalf of a third party buyer acceptable to us.

4.4 Commission Bids

If you give us instructions to bid on your behalf, by using the form provided in our catalogues or via our website, we shall use reasonable endeavors to do so, provided these instructions are received not later than 24 hours before the auction. If we receive commission bids on a particular Lot for identical amounts, and at auction these bids are the highest bids for the Lot, it will be sold to the person whose bid was received first. Commission bids are undertaken subject to other commitments at the time of the sale, and the conduct of the auction may be such that we are unable to bid as requested. Since this is undertaken as a free service to prospective buyers on the terms stated, we cannot accept liability for failure to make a commission bid. You should therefore always attend personally if you wish to be certain of bidding. All commission bids should be sent to 4&5/F, Hua Fu Commercial Building, 111 Queen's Road West, Hong Kong up till 24 hours prior to the sale.

4.5 On-line Bidding

We offer internet services as a convenience to our clients. We will not be responsible for errors or failures to execute bids placed on the internet, including, without limitation, errors or failures caused by (i) a loss of internet connection by either party for whatever reason; (ii) a breakdown or problems with the online bidding software and/or (iii) a breakdown or problems with the online bidding software and/or (iii) a breakdown or problems with the online bidding software and/or (iii) of on-line internet bids on www.spink.com and Spink Live is a free service undertaken subject to other commitments at the time of the auction and we do not accept liability for failing to execute an online internet bid or for errors or omissions in connection with this activity.

4.6 Telephone Bids

If you make arrangements with us not less than 24 hours before the sale, we shall use reasonable endeavors to contact you to enable you to participate in bidding by telephone, but in no circumstances will we be liable to either the Seller or you as a result of failure to do so.

4.7 Currency Converter

At some auctions, a currency converter will be operated, based on the one month forward rates of exchange quoted to us by HSBC or any other appropriate rate determined by us, at opening on the date of the auction. Bidding will take place in a currency determined by us, which is usually Hong Kong dollars for auctions held in Hong Kong. The currency converter is not always reliable, and errors may occur beyond our control either in the accuracy of the Lot number displayed on the converter, or the foreign currency equivalent of Hong Kong dollar bids. We shall not be liable to you for any loss suffered as a result of you following the currency converter.

4.8 Video images

At some auctions there will be a video screen. Mistakes may occur in its operation, and we cannot be liable to you regarding either the correspondence of the image to the Lot being sold or the quality of the image as a reproduction of the original.

4.9 Bidding Increments

Bidding generally opens below the low estimate and advances in the following order although the auctioneer may vary the bidding increments during the course of the auction. The normal bidding increments are:

4.10 Bidding by the Spink Group

4.10.1 We reserve the right to bid on Lots on the Seller's behalf up to the amount of the Reserve (if any), which will never be above the low estimate printed in the auction catalogue.

4.10.2 The Spink Group reserves the right to bid on and purchase Lots as principal.

4.10.3 Lots with this symbol \supseteq indicate that a party has provided Spink with an irrevocable bid on the lot that will be executed during the sale at a value that ensures that the lot will sell. The irrevocable bidder, who may bid in excess of the irrevocable bid, will be compensated based on his bid in the event he or she is not the successful bidder or may receive a fixed fee in the event he or she is the successful bidder. If the irrevocable bidder is the successful bidder, the fixed fee for providing the irrevocable bid may be netted against the irrevocable bidder's obligation to pay the full purchase price for the lot. If the irrevocable bid is not secured until after the printing of the auction catalogue, a pre-sale announcement will be made indicating that there is an irrevocable bid on the lot. If you are interested in placing an irrevocable bid in an auction, please contact us at chairmanoffice@spink.com. Typically, only some of the lots with an estimate, which must exceed £100,000 or equivalent in other currencies, are open to irrevocable bids.

4.11 The Auctioneer's Discretion

The auctioneer has the right at his absolute discretion to refuse any bid to advance the bidding in such manner as he may decide to withdraw or divide any Lot, to combine any two or more Lots and, in the case of error or dispute, to put an item up for bidding again.

4.12 Successful Bid

Subject to the auctioneer's discretion, the striking of his hammer marks the acceptance of the highest bid, provided always that such bid is higher than the Reserve (where applicable), and the conclusion of a contract for sale between you and the Seller.

4.13 After Sale Arrangements

If you enter into any private sale agreements for any Lot with the Seller within 60 days of the auction, we, as exclusive agents of the Seller reserve the right to charge you the applicable Buyer's Premium in accordance with these Terms and Conditions, and the seller a commission in accordance with the terms of the seller's agreement.

4.14 Return of Lot

4.14.1 Once your bid has been accepted for a Lot then you are liable to pay for that Lot in accordance with these Terms and Conditions. If there are any problems with a Lot then you must notify us within 7 days of receipt of the Lot, specifying the nature of the problem. We may then request that the Lot is returned to us for inspection. Save as set out in clause 5.9, the cancellation of the sale of any Lot and the refund of the corresponding purchase price is entirely at our sole discretion. We will not normally exercise that discretion if the Lot is not received by us in the same condition that it was in at the auction date.

4.14.2 No lot may be returned on account of condition if the condition was stated by a third party grading company (including, but not limited to PCGS, NGC, ANACS, ICG, PMG, WBG, Legacy Currency Grading).

5 AFTER THE AUCTION

5.1 Buyer's Premium

In addition to the Hammer Price, you must pay us the Buyer's Premium at a rate of 20% of the final Hammer price of each lot, postage charge and a fee for paying by credit card.

5.2 Payment

5.2.1 You must provide us with your full name and permanent address and, if so requested, details of the bank from which any payments to us will be made. You must pay the full amount due on your invoice within seven days after the date of the sale. This applies even if you wish to export the Lot and an export license is (or may be) required.

5.2.2 You will not acquire title to the Lot until all amounts due to us have been paid in full. This includes instances where special arrangements were made for release of Lot prior to full settlement.

5.2.3 Payment should be made in Hong Kong Dollars by one of the following methods:

(i) Direct bank transfer to our account details of which are set out on the invoice. All bank charges shall be met by you. Please ensure that your client number is noted on the transfer.

(ii) By cheque or bank draft made payable to Spink China Limited. Please note that the processing charges for payments made by cheques or bank drafts drawn on a non-Hong Kong bank shall be met by you. Please ensure that the remittance slip printed at the bottom of the invoice is enclosed with your payment.

(iii) By Visa, Mastercard or CUP. A fee of 4% will be applied. We are not responsible for any foreign exchange losses or charges that you may incur in connection with such card payments.

5.2.4 Payments should be made by the registered buyer and not by third parties, unless it has been agreed at the time of registration that you are acting as an agent on behalf of a third party.

5.3 Notification

We are not able to notify successful bidders by telephone. While Invoices are sent out by mail after the auction we do not accept responsibility for notifying you of the result of your bid. You are requested to contact us by telephone or in person as soon as possible after the auction to obtain details of the outcome of your bids to avoid incurring charges for late payment.

5.4 Collection, Packing and Handling of Purchases

5.4.1 Unless specifically agreed to the contrary, we shall retain lots purchased until all amounts due to us, or to the Spink Group, have been paid in full. Buyers will be required to pay for their lots when they wish to take possession of the same, which must be within 7 days of the date of the sale, unless prior arrangements have been made with Spink. Without prior agreement, lots will not be released until cleared funds are received with regard to payments made by cheque.

5.4.2 Lots may be collected from 4&5/F, Hua Fu Commercial Building, 111 Queen's Road West, Hong Kong. In the event where a cheque or bank draft payable to Spink China Limited has been presented to us, unless we specifically agree to the contrary, no Lots shall be released before the cheque or bank draft has cleared where such funds have been credited into our bank account.

5.4.3 A purchased Lot shall be at your risk in all respects from the time of collection or the expiry of seven days from the date of sale, whichever is sooner, and neither Spink China Limited nor its employees nor agents shall thereafter be liable for any loss or damage of any kind, whether caused by negligence or otherwise, while any Lot is in or under their respective custody or control.

5.4.4 If required our shipping department may arrange shipment as your agent. Although we may suggest carriers if specifically requested, our suggestions are made on the basis of our general experience of such parties in the past and we are not responsible to any person to whom we have made a recommendation for the acts or omissions of the third parties concerned.

5.4.5 We shall use all reasonable endeavors to take care when handling and packing a purchased Lot but remind you that after seven days or from the time of collection, whichever is sooner, the Lot is entirely at your risk.

5.4.6 It is the responsibility of the Buyer to be aware of any Import Duties that may be incurred upon importation to the final destination. Spink will not accept return of any package in order to avoid these duties. The onus is also on the Buyer to be aware of any Customs import restrictions that prohibit the importation of certain collectibles. Spink will not accept return of the Lot(s) under these circumstances. Spink will not accept responsibility for Lot(s) seized or destroyed by Customs.

5.4.7 If the Buyer requires delivery of the Lot to an address other than the invoice address this will be carried out at the discretion of Spink.

5.5 Remedies for non-payment or failure to collect purchases

5.5.1 If you fail to make payment within seven days of your stipulated payment date set out in your invoice, we shall be entitled to exercise one or more of the following rights or remedies:

5.5.1.1 to charge interest at the rate of 2% per month compound interest, calculated on a daily basis, from the date the full amount is due;

5.5.1.2 to set off against any amounts which the Spink Group may owe you in any other transaction the outstanding amount remaining unpaid by you;

5.5.1.3 we may keep hold of all or some of your Lots or other property in the possession of the Spink Group until you have paid all the amounts you owe us or the Spink Group, even if the unpaid amounts do not relate to those Lots or other property. Following fourteen days' notice to you of the amount outstanding and remaining unpaid, the Spink Group shall have the right to arrange the sale of such Lots or other property. We shall apply the proceeds in discharge of the amount outstanding to us, and pay any balance to you;

5.5.1.4 where several amounts are owed by you to the Spink Group in respect of different transactions, to apply any amount paid to discharge any amount owed in respect of any particular transaction, whether or not you so direct;

5.5.1.5 to reject at any future auction any bids made by you or on your behalf or obtain a deposit from you before accepting any bids.

5.5.2 If you fail to make payment within thirty-five days, we shall in addition be entitled:

5.5.2.1 to cancel the sale of the Lot or any other item sold to you at the same or any other auction;

5.5.2.2 to arrange a resale of the Lot, publicly or privately, and, if this results in a lower price being obtained, claim the balance from you together with all reasonable costs including a 20% seller's commission, expenses, damages, legal fees, commissions and premiums of whatever kind associated with both sales or otherwise, incurred in connection with your failure to make payment; or

5.5.2.3 when reselling the Lot, place a notice in our catalogue stating that you successfully purchased the Lot at auction but have subsequently failed to pay the Hammer Price of the Lot; or

5.5.2.4 take any other appropriate action as we deem fit.

5.6 Failure to collect

Where purchases are not collected within fourteen days after the sale, whether or not payment has been made, you will be required to pay a storage charge of HKD30 per item per day plus any additional handling cost that may apply. You will not be entitled to collect the Lot until all outstanding charges are met, together with payment of all other amounts due to us.

5.7 Use of Default Information

If you fail to make payment for a Lot in accordance with these Terms and Conditions

5.7.1 we reserve the right to refuse you the right to make bids for any future auction irrespective of whether previous defaults have been settled; and

5.7.2 you acknowledge that we may (as necessary for our legitimate interests those of other auctioneers and live bidding platforms in referencing customers and avoiding customer defaults) disclose details of such default to other auctioneers and live bidding platforms, which will include your name, address, nature of the default and the date of the default.

Auctioneers or live bidding platforms who receive details of the default may rely on such information when deciding whether to enter into a transaction with you in the future.

5.8 Export License

5.8.1 You should always check whether an export licence is required before exporting.

5.8.2 Unless otherwise agreed by us in writing, the fact that you wish to apply for an export license does not affect your obligation to make payment within seven days nor our right to charge interest on late payment.

5.8.3 We will not be obliged to rescind a sale nor to refund any interest or other expenses incurred by you where payment is made by you despite the fact that an export license is required.

5.9 Refund in the case of Forgery

5.9.1 A sale will be cancelled, and the amount paid refunded to you if a Lot (other than a miscellaneous item not described in the catalogue) sold by us proves to have been a Forgery. We shall not however be obliged to refund any amounts if either (a) the catalogue description or saleroom notice at the auction date corresponded to the generally accepted opinion of scholars or experts at that time, or fairly indicated that there was a conflict of opinions, or (b) it can be demonstrated that the Lot is a Forgery only by means of either a scientific process not generally accepted for use until after publication of the catalogue or a process which at the date of the auction was unreasonably expensive or impracticable or likely to have caused damage to the Lot. Furthermore, you should note that this refund can be obtained only if the following conditions are met:

5.9.1.1 you must notify us in writing, within seven days of the auction date, that in your view the Lot concerned is a forgery;

5.9.1.2 you must then return the item to us within fourteen days, in the same condition as at the auction date; and

5.9.1.3 as soon as possible following return of the Lot, you must produce evidence satisfactory to us that the Lot is a Forgery and that you are able to transfer good title to us, free from any third party claims.

5.9.1.4 you must provide to us all evidence obtained by you that a Lot is a Forgery no later than 7 days after you receive such evidence.

5.9.2 In no circumstances shall we be required to pay you any more than the amount paid by you for the Lot concerned and you shall have no claim for interest.

5.9.3 The benefit of this guarantee is not capable of being transferred, and is solely for the benefit of the person to whom the original invoice was made out by us in respect of the Lot when sold and who, since the sale, has remained the owner of the Lot without disposing of any interest in it to any third party.

5.9.4 We shall be entitled to rely on any scientific or other process to establish that the Lot is not a Forgery, whether or not such process was used or in use at the date of the auction.

6 LIABILITY

Nothing in these Terms and Conditions limits or excludes our liability for:

6.1 death or personal injury resulting from negligence; or

6.2 any damage or liability incurred by you as a result of our fraud or fraudulent misrepresentation.

7 USE OF YOUR PERSONAL INFORMATION

7.1 We will use the personal information you provide to us as set out in our privacy notice (available at https://spink.com/privacy-policy) and in particular to:

7.1.1 process the bids you make on Lots (whether successful or otherwise) and other auction related services we provide;

7.1.2 process your payment relating to a successful purchase of a Lot;

7.1.3 arrange for delivery of any Lot you purchase, which will include passing your details to shipping providers and, on overseas deliveries, to customs where they make enquiries regarding the Lot;

7.1.4 inform you about similar products or services that we provide, but you may stop receiving these at any time by contacting us.

7.2 In accordance with clause 4.2, we may pass your information to credit reference agencies in order to obtain credit checks from them, and they may keep a record of any search that they do.

7.3 In accordance with clause 5.7, where you default on making payment for a Lot in accordance with these terms and conditions we may disclose details of such default to other auctioneers and live bidding platforms.

7.4 We are also working closely with third parties (including, for example, other auctioneers and live bidding platforms) and may receive information about you from them.

7.5 Where you provide us with personal information about other individuals, you must ensure that your provision of that information is compliant with applicable data protection law.

8 COPYRIGHT

8.1 We shall have the right (on a non-exclusive basis) to photograph, video or otherwise produce an image of the Lot. All rights in such an image will belong to us, and we shall have the right to use it in whatever way we see fit.

8.2 The copyright in all images, illustrations and written material relating to a Lot is and shall remain at all times our property and we shall have the right to use it in whatever way we see fit. You shall not use or allow anyone else to use such images, illustrations or written material without our prior written consent.

9 NOTICES

All notices given under these Terms and Conditions may be served personally, sent by 1st class post, or faxed to the address given to the sender by the other party. Any notice sent by post will be deemed to have been received on the second working day after posting or, if the addresse is overseas, on the fifth working day after posting. Any notice sent by fax or served personally will be deemed to be delivered on the first working day following dispatch.

10 ADDITIONAL PROVISIONS

10.1 Limitation of Liability

Subject to clause 6, we shall not be liable, whether in tort (including for negligence) or breach of statutory duty, contract, misrepresentation or otherwise for any:

10.1.1 loss of profits, loss of business, depletion of goodwill and/or similar losses, loss of anticipated savings, loss of goods, loss of contract, loss of use, loss of corruption of data or information; or

10.1.2 any special, indirect, consequential or pure economic loss, costs, damages, charges or expenses.

10.2 Severability

If any part of these Terms and Condition is found by any court to be invalid, illegal or unenforceable, that part may be discounted and the rest of the conditions shall continue to be valid and enforceable to the fullest extent permitted by law.

10.3 Force majeure

We shall have no liability to you if we are prevented from, or delayed in performing, our obligations under these Terms and Conditions or from carrying on our business by acts, events, omissions or accidents beyond our reasonable control, including (without limitation) strikes, lock-outs or other industrial disputes (whether involving our workforce or the workforce of any other party), failure of a utility service or transport network, act of God, war, riot, civil commotion, malicious damage, compliance with any law or governmental order, rule, regulation or direction, accident, breakdown of plant or machinery, fire, flood, storm or default of suppliers or subcontractors.

10.4 Waiver

10.4.1 A waiver of any right under these Terms and Conditions is only effective if it is in writing and it applies only to the circumstances for which it is given. No failure or delay by a party in exercising any right or remedy under these Terms and Conditions or by law shall constitute a waiver of that (or any other) right or remedy, nor preclude or restrict its further exercise. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that (or any other) right or remedy.

10.4.2 Unless specifically provided otherwise, rights arising under these Terms and Conditions are cumulative and do not exclude rights provided by law.

10.5 Law and Jurisdiction

10.5.1 These Terms and Conditions and any dispute or claim arising out of or in connection with them or their subject matter, shall be governed by, and construed in accordance with Hong Kong laws.

10.5.2 The parties irrevocably agree that the courts of Hong Kong shall have nonexclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, Terms and Conditions or their subject matter.
