NOTICE TO BIDDERS

Dear Bidder, we welcome you to our auction house. Please note the points below to assist you with the registration, bidding and payment at our auctions.

REGISTRATION FOR BIDDING:

BIDDING METHODS:

ID information is collected for registration purposes only and will be kept confidential.

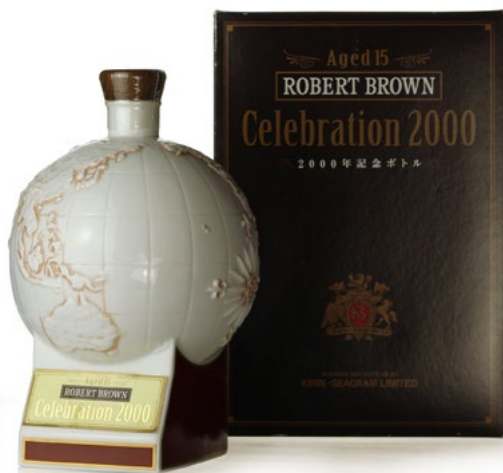

The casks used for this single malt were a combination of vintages from 1868, 1878, 1922, 1926 and 1939.

Cask one chosen was distilled in June 1868. Having aged for a dozen of years, in August 1880 and October 1891, the whisky was twice transferred (re-racked) into another sherry wood for more characters.

The second cask went through a similar path. Distilled February 1878, re-racked April 1890 and April 1908.

Cask three, distilled March 1922.

Then these three casks were each re-racked once again in the year of 1926, into another three barrels where they were then laid quietly for 55 years, until September 1977, that they were once again disturbed, and this time combined the three into one single butt where it sat for another few months. On February 1978, the vat was then removed from wood and set quietly in glass.

Like the history above was not rich enough, there were another two casks picked to craft this one fine expression: cask four and five were both distilled in 1939, after 52 years in wood, they were set aside in glass in October 1991.

These two 1939 whiskies were later vatted into the former mix by Master Distiller, Richard Patterson, and the result? 191 bottles of this miniature decanters full of The Dalmore's finest life.

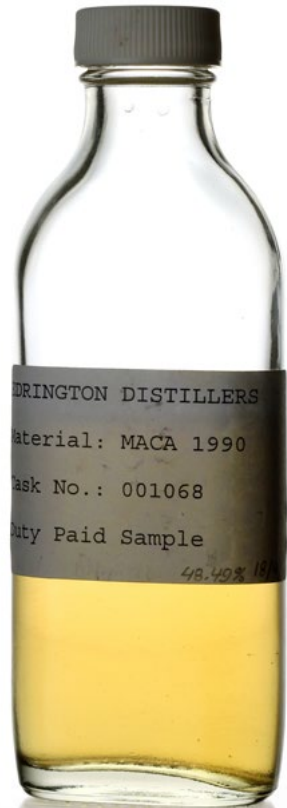

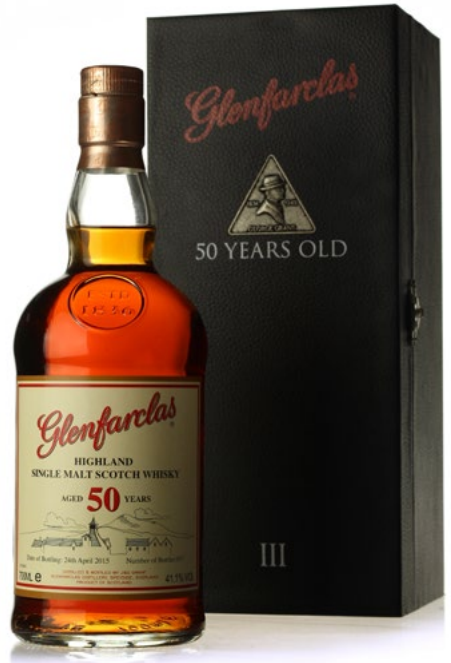

CONDITIONS OF BUSINESS

Spink China Ltd (hereafter referred to as Spink) and Buyer hereby agree to the following Terms and Conditions for auctions conducted by Spink China Ltd.

1 The Buyer

The highest bidder shall be the Buyer at the 'hammer price' and any dispute shall be settled at the auctioneer's absolute discretion. Every bidder shall be deemed to act as principal unless there is in force a written acknowledgement by Spink that he/she acts as agent on behalf of a named principal.

2 The Premium

The buyer shall pay to Spink a premium of 22% of the hammer price on all lots.

3 Bidder Registration

Bidding is strictly by paddle only. All floor bidders are requested to register prior to bidding. You must complete and sign a registration form and provide an identification before making a bid at auction. Please be aware that we usually require buyers to undergo a credit check.

4 Payment

After a lot is sold the Buyer must pay to Spink the 'total amount due' within seven days after the date of the sale.

Any payments by a Buyer to Spink may be applied by Spink towards any sums owing from that Buyer to Spink on any account whatever without regard to any directions of the buyer or his agent, whether express or implied.

5 Ownership

The ownership of the lot purchased shall not pass to the buyer until he has made payment in full to Spink of the 'total amount due'.

6 Collection of Purchases

(a) The Buyer shall at his own expense take away the lot purchased not later than 7 working days after the day of the auction but not before payment to Spink of the 'total amount due'.

(b) The buyer shall be responsible for any removal, storage and insurance charges on any lot not taken away within 8 working days after the day of the auction. Please refer to the table explaining additional costs depending on where lots are lying.

7 Buyers responsibilities for lots purchased

The buyer will be responsible for loss or damage to lots purchased from the time of collection or the expiry of 7 working days after the day of the auction, whichever is the sooner, and neither Spink nor its respective staff or agents shall thereafter be responsible for any loss or damage of any kind, whether caused by negligence or otherwise, while any lot is in their custody or under their control.

It is the responsibility of the Buyer to be aware of any Import Duties that may be incurred upon importation to the final destination. Spink will not accept return of any package in order to avoid these duties. The onus is also on the Buyer to be aware of any Customs import restrictions that prohibit the importation of certain collectibles. Spink will not accept return of the Lot(s) under these circumstances. Spink will not accept responsibility for lots seized or destroyed by Customs.

If the Buyer requires delivery of the lot to an address other than the invoice address this will be carried out at the discretion of Spink.

8 Remedies for non-payment or failure to collect purchases

If any lot is not paid for in full and taken away in accordance with Conditions 4, 6 and 7, or if there is any other breach of either of those Conditions, Spink as agent of the Seller shall, at its absolute discretion and without prejudice to any other rights they may have, be entitled to exercise one or more of the following rights and remedies:

(a) to proceed against the Buyer for damages for breach of contract;

(b) to rescind the sale of that or any other lots sold to the defaulting buyer at the same or any other auction;

(c) to re-sell the lot or cause it to be re-sold by public auction or private sale and the defaulting Buyer shall pay to Spink any resulting deficiency in the 'total amount due' (after deduction of any part payment and addition of re-sale costs) and any surplus shall belong to the Seller;

(d) when reselling the Lot, place a notice in our catalogue stating that you successfully purchased the Lot at auction but have subsequently failed to pay the Hammer Price of the Lot; or

(e) to remove, store and insure the lot at the expense of the defaulting Buyer and, in the case of storage, either at Spink or elsewhere;

(f) to charge interest at a rate of 2% per month on the 'total amount due' to the extent it remains unpaid for more than 7 working days after the day of the auction;

(g) to retain that or any other lot sold to the same Buyer at the same or any other auction and release it only after payment of the 'total amount due';

(h) to reject or ignore any bids made by or on behalf of the defaulting Buyer at any future auctions or obtain a deposit before accepting any bids in future;
